CHAPTER-1

IMPORTANT INFORMATION FOR THE SESSION 2024-25

1. The Admission Brochure is for admission to B.E/B. Tech/B. Arch. Courses for the Academic Year 2024-25. ***Its contents are subject to change without prior notice Therefore, visit HSTES website regularly for updates.***
2. Admissions to B.E/B. Tech. (Including candidates under **Tuition Fee Waiver (TFW) scheme/ Economically Weaker Sections (EWS)/ Kashmiri Migrants (K.M.)/ Haryana Government School Toppers (HGST)** shall be made on the basis of the **inter-se-merit of JEE (Main)-2024** through two on-line off-campus counseling on <https://techadmissionshry.gov.in>.
3. **Admission to B.Arch** shall be made on the basis of combined merit prepared either from the **percentile of NATA-2024 score or percentile of** any other aptitude test recognized by the COA and **Percentage of marks of qualifying exam in 50:50** through two on-line off-campus counseling on <https://techadmissionshry.gov.in>.
4. There is no printed application form available/ acceptable. Further, applications for admission in all B.Tech./B.Arch. Courses (including all categories) shall be invited online at <https://techadmissionshry.gov.in>. as per “Key Dates” given in **Appendix-K**.
5. The candidates of Haryana have to fill the PPP ID online and also have to upload their coloured photograph (JPG, JPEG File Max. 30KB Size) and signature (JPG, JPEG File Max. 20KB Size).
6. The candidates from other State have to fill the particulars online and also have to upload their coloured photograph (JPG, JPEG File Max. 30KB Size) and signature (JPG, JPEG File Max. 20KB Size) of other state.
7. The particulars of the candidate in the application form must exactly be the same as registered in the qualifying examination.
8. The candidates are advised to provide personal mobile number and email id as the same will be used to communicate any advisory/ notification related to admissions.
9. The candidates are advised to clearly opt the course as per their eligibility i.e. B.Tech. / B.Arch. and special category i.e. HGST/ KM/ TFW/ EWS’s.
10. The candidates should note down the unique application number which will be generated as the candidate sign up for the above Courses. The unique application number will be required for future communication. The candidate should keep a copy of application form for his/ her record.
11. The candidates, who belongs to Haryana State, shall provide their Parivar Pehchan Patra (PPP) ID or Aadhaar No. (If applicant does not remember PPP ID) during sign up/registration at www.techadmissionshry.gov.in. All related data of the applicant like **name, gender, DOB, father name, mother name, income, category & sub category** will be

fetched from his/her PPP ID data base and these details fetched from PPP database will be non-editable. **So that all the candidates from Haryana State will have to get his/her details updated and verified on PPP portal first.**

12. The candidates, who belong to the State other than Haryana, shall provide their Aadhaar No. during sign up/registration at www.techadmissionshry.gov.in. In case the Aadhar No. of any candidate of other state is available in PPP Data base, then the candidate will not be allowed to register as of other state candidate during registration.
13. In case the Aadhar No. of any candidate of other state is available in PPP Data base, the candidate will not be allowed to register as other state candidate.
14. The candidate, who belongs to the State of Haryana, need not to upload the documents of his/her category (SC, BC, General etc.), Annual Family Income, Date of Birth during registration on <https://techadmissionshry.gov.in> as the same will be fetched and verified from PPP Data base. However, the candidates are required to upload the pdf of documents of his/her sub category like ESM, FF & Special Categories like EWS etc.
15. During the filling of Online Application Form, the candidates applying for B.Arch. course including EWSs category shall upload the scanned copy of PDF Detailed Marks Certificate (DMC) of 10th (for Date of Birth verification) and DMC of qualifying Examination and score card of NATA-2024 exam or result card of any other aptitude test recognized by COA at the time of filling the online application form for Verification & Confirmation of Online Filled Application Form by the HSTES, Panchkula as per the notified schedule and instructions.
16. After submission of online application form for B.E./B.Tech. & B.Arch. course, the candidates are advised to deposit the Registration Fees online.
17. The candidates are advised to check their all the particulars like name, father name, date of birth, category, resident of Haryana, income etc. fetched from the PPP ID during the online registration correctly. In case of any discrepancy, candidate will have to get the details updated and verified by PPP portal and this updated PPP data can be fetched again by the verified before verifying the details during online registration.
18. The candidates are advised to fill all the particulars like name, father name, date of birth, category, resident of Haryana, income, economically weaker category etc. in the online application form correctly. If the particulars of any candidate are found wrong at the time of reporting of admission then his/ her admission may be cancelled and the candidate himself/ herself will be responsible for the canceling of the said admission. If any candidate wants to correct his/ her editable particulars (except the details fetched/verified from PPP ID) after submission of online application form he/ she may contact HSTES on email id onlineadmissionhelp@gmail.com and at the toll free no. 1800-137-3735 before the last date of closing of application form.
19. A candidate shall be allowed to change his/ her registration details (except the details fetched from PPP ID) before submission of the registration fee or confirmation of details. .
20. The candidates are required to complete 07 stages for registration at www.techadmissionshry.gov.in i.e. Application Form, Other Details, upload photo &

signatures, filling marks of qualifying examination, confirm his/her details, upload the requisite documents in pdf & pay applicable fees.

21. The Registration Fees for B.E/B. Tech. & B.Arch. course shall be deposited by the candidate Online through Debit Card/ Credit Card/ Net Banking/UPI by using online payment gateway during filling the online application form.

Note: The Online Registration Fee once paid shall not be refunded (full or partial) under any circumstances. The service charges will be charged from payer for using online payment gateway.

Registration Fees: Rs. 1000/- for General Category

Rs. 700/- for All Reserved Categories
(SC/ SCD/BC/PH/FF/ESM/KM/Girls)

22. The filling up of choices for Online Counseling's will be done for those candidates only who have deposited the Online Registration Fees.

23. The verification of application forms of B.Arch. will be done for those candidates only who have deposited the Online Registration Fees.

24. The candidates can visit nearby Common Service Centers (CSC) or nearby Government Polytechnics/ HSTES for filling the online application form/ deposit of fees/ filling choices for counseling etc. (Common Service Centres are physical facilities for delivering Government of India e-Services to rural and remote locations where availability of computers and Internet was negligible or mostly absent).

25. After submission of online registration forum along with fees at www.techadmissionshry.gov.in, candidate have to login with Unique Application No. & Password. Upon login, candidate will be able to fill choices online. A candidate who has selected special category, will be able to fill choices for different Roll No's i.e. General Roll No. & Special Category Roll No. through same login.

For Example: A Candidate namely "SUMIT" has registered for Diploma Engg. Course and got the Unique Application: 100005. Upon Registration, Sumit has applied for Special Category as well i.e. TFW. Now, while filling the Choices Online, Sumit will be able to Fill Choices for 2 different Roll No.'s i.e. General Roll No. (DE100005) & TFW Special Category Roll No. (WE100005).

26. Candidates of KM, TFW, EWS & HGST categories of B.E/B. Tech. course are required to select his /her category during filling online application form on <https://techadmissionshry.gov.in>. He/She will get unique application number after submission of online application form. The **unique application form number** may be used by the candidate for any correspondence with HSTES, Panchkula.

27. **PPP ID shall remain mandatory for Haryana students for taking admissions in B.E/ B.Tech & B.Arch. Course and during the applying online for these courses at <https://techadmissionshry.gov.in> , the PPP ID must be filled by the Haryana Candidates. The details of the candidate like his/her name, father name, mother name, Annual Family Income, Category etc. will be fetched from their PPP ID which should be marked as verified in family information data repository (FIDR). The**

caste/reservation/annual income/financial benefits given to the candidate shall be on the basis of verified caste/income fetched through PPP as per the State Govt.

28. Any unverified data of PPP of the candidate shall lead to his candidature considered in general category only. **So that all the candidates seeking admission are advised to get their PPP ID get updated & verified.**
29. The candidate of EWS Category of B. Tech. course shall upload his/her Income & Asset Certificate for EWS category issued by competent authority (PDF of Max 100 KB Size for each document) at the time of registration.
30. **KM category** of B. Tech. course candidates shall upload his/her Migration Certificate duly signed by Competent Authority or Relief Commissioner (in case of KM), Detailed Marks Certificate of Qualifying exam and proof of Date of Birth (PDF of Max. 100 KB Size for each document), recent passport size Colored Photograph (JPG File Max. 30KB Size) and Specimen Signature (JPG File Max. 20KB Size) during filling the online application form on website <https://techadmissionshry.gov.in>.
31. **HGST category** of B. Tech. course candidates shall upload his/her HGST certificate from the Principal of the Govt. School of Haryana of which the candidate is topper as per **Annexure-X** (PDF of Max. 100 KB Size), recent passport size Colored Photograph (JPG File Max. 30KB Size) and Specimen Signature (JPG File Max. 20KB Size) during filling the online application form on website <https://techadmissionshry.gov.in>.
32. Before submitting the online application form, the candidate can check and edit his/her registration details except the details fetched & verified from PPP data base. Further, the candidate should also ensure that the photograph, signature, Detailed marks Certificate of qualifying examination & proof of Date of Birth and Migration Certificate duly signed by Competent Authority or Relief Commissioner (in case of KM)/certificate from the Principal of the Govt. School of Haryana of which the candidate is topper (in case of HGST) uploaded are his/her own and registration details of the candidate must be same as per the qualifying exam & JEE(MAIN)-2024 rank card.
33. Before submitting the online application form of B. Tech. (for EWS/TFW category), the candidate can check his/her registration details. Further, the candidate should also ensure that the photograph, signature uploaded are his/her own and registration details of the candidate must be same as per the qualifying exam & JEE(MAIN)-2024 rank card.
34. Submission of duplicate application is not allowed. In case, if a candidate wants to correct/update certain detail(s) submitted in his/ her online application form (except the details fetched & verified from PPP ID), same would be done upto the last date of submission of online application form by the HSTES, Panchkula as per key-dates along with the required documents.
35. Admissions for B. Arch Course shall be made on the basis of valid NATA-2024 score in percentile form/ Percentile of any other aptitude test recognized by the COA as declared by Council of Architecture (COA) and marks secured in the qualifying examination in the ratio of 50:50.
36. The candidates applying for B. Arch Course shall upload his/her Rank card (PDF of Max

100 KB Size) of Score card of valid NATA -2024 or any other aptitude test recognized by the COA Rank Card and Detailed marks Certificate of Qualifying exam (PDF of Max 100 KB Size) along with other documents on online application form on website <https://techadmissionshry.gov.in>.

37. For B. Arch. Course, **Registration cum Application Fee** shall be deposited by the candidate through Credit/Debit Card or Net-banking by using online payment gateway during filling the online application form.

Registration cum Application Fee:

- Rs.700/- for (SC/ SCD/BC/PH/FF/ESM/KM/Girls)
- Rs.1000/- for General Category.

The Application Fee once paid shall not be refunded (full or partial) under any circumstances.

38. Online application filled by candidate for B.Arch. Course will be verified by the HSTES w.r.t. his/ her credentials, marks etc. which were asked to fill and after verification by the HSTES, Inter-se-Merit will be prepared.
39. The **Merit List for B. Arch.** Course shall be displayed on the website www.hstes.org.in as per "KEY DATES". **No separate result card will be sent to the candidates.**

Note: The merit of those candidates will not be prepared, who have not uploaded his/her documents of qualifying examination, NATA 2024/ any other aptitude test recognized by the COA Score card & have not deposited the online registration fee. Moreover their online application is liable to be rejected by the HSTES, Panchkula and no correspondence or request will be entertained in this regard thereafter.

40. The Centralized counseling would be done on website <https://techadmissionshry.gov.in>. Candidate shall upload the requisite documents i.e. Special Category Certificate and sub category (other than fetched & verified from PPP ID) etc. **see Chapter 8** in scanned PDF Format of 100 KB size and their PPP ID during registration process. A candidate shall be allowed to change his/her registration details (except the details fetched & verified from his/her PPP ID) before confirmation of Application Form.
41. The fee structure of various self-financing technical institutions is available at **Appendix-F** and on the website www.techeduhry.gov.in. Candidates are advised in their own interest to see the fee structure of institutes on the website of concerned institute/ University and on the website www.techeduhry.gov.in before filling the choices of branch and institute during online counseling.
42. Locking of filled choices is advisable, however, candidates who do not lock the choices, their last filled choice would be considered as final.
43. During Counseling, Registration for online counseling on <https://techadmissionshry.gov.in> will be allowed prior to the respective counseling as per the dates mentioned in "Key Dates" for B.Tech. courses as per Roll number of JEE Main-2024. The candidates who have registered before 1st Online-Off-Campus counseling at <https://techadmissionshry.gov.in> need not register again for participating in 2nd

Online-Off-Campus counseling. **On registration, password has to be created by the candidate, for use in future logins. Candidates are advised to keep records of this password secretly for their own use only and not to disclose this to others.** In the event of sharing of password, candidate will be solely responsible for the change of registration details, choices etc.

44. **Candidates are advised to register for Online Counseling and fill choices from their own home or by going to participating institution and SHOULD NOT go to any cyber cafe or any outside unauthorized persons for the same, as they may mislead or misguide you.**
45. After closing of 1st counseling, the candidate will see the result of 1st counseling as per key dates.
46. After declaration of the result of first counseling, Candidate shall report as per provisional seat allotment letter to the allotted institute and deposit the semester fee for confirmation of seat. (Please read the allotment letter and **chapter 7 & 8** carefully). The allotted institute shall verify the credentials uploaded by the candidates with in time and confirm the admission of the candidate on intra portal of HSTES and issue **Provisional Admission Slip** to the candidate as a proof of his/her admission. In case, the candidate fails to report as per the key dates or the documents / fees uploaded are found incorrect, then his/ her allotted seat will be forfeited/ cancelled automatically.
47. To participate in 2nd counseling & subsequent counseling (if any), candidates will have to again fill (refill) the choices in the order of priority on the counseling website <https://techadmissionshry.gov.in>. Admission procedure for filling of choices of Branch/Institute shall remain the same. In case seat is allotted in 2nd or subsequent counseling, the earlier allotted/reported seat will be **cancelled automatically** & the candidate will have to report online again to the institute allotted in 2nd or Subsequent counseling. Thus candidates are advised to fill the choices in order of priority only to upgrade. **The candidate who is satisfied with his/her earlier admission & wish to retain the reported seat shall not opt for subsequent counseling.**
48. Tuition Fee Waiver (TFW) / Kashmiri Migrant (KM)/Haryana Govt. School Topper (HGST)/Economically Weaker Section (EWS) Counseling shall be done parallel to the general counseling as per the rank of **JEE Main 2024**. Tuition Fee Waiver Scheme of AICTE can be seen at **Appendix-I**.
49. After declaration of the result of first counseling, the candidate shall report in the allotted institute as per schedule mentioned in the provisional seat allotment letter generated from the website for admission against the allotted seat alongwith all requisite documents/ certificates/ testimonials in original, photograph as mentioned in **Chapter-8** and password. The allotted institute shall verify the credentials online uploaded by the candidates with in time and confirm the admission of the candidate on intra portal of HSTES and issue **Provisional Admission Slip** to the candidate online as a proof of his/her admission. The candidate **MUST** get the Provisional Admission Slip from the allotted institute dully signed by the admission coordinator of the institute and the candidate himself/ herself. In case, the candidate fails to report online/ offline as per the key dates or the documents uploaded are found incorrect, then his/ her allotted seat will be

forfeited/ cancelled automatically

50. After successful reporting to the allotted institute, the institute **MUST** issue an online generated **Provisional Admission Slip** to the candidate as per Key-Dates.
51. The institute must update the status of reporting/ non-reporting by a candidate by simply tick marking the checklist online by checking all the parameters of the check list. The online generated admission slip shall be given to the candidate after successful reporting.
52. Fulfilling eligibility for B.E/B. Tech. w.r.t. qualification and percentage of qualifying exam shall be proved by the candidate at the time of registration for online centralized counseling. **The candidate may seek admission at his/her own risk and cost and if he/she is found ineligible at the time of physical reporting, his/her entire dues shall be forfeited and his/her admission shall be cancelled for which he/she shall have no claim, whatsoever.**
53. For the guidance of candidates, list of Institutes along with branches and sanctioned intake thereof is provided at **Appendix-G**. Candidates must go through this **Appendix-G** for preparation of his/her mind set for selection of preference of choices to be filled by the candidate during online counseling. For details of List of Institutes along with branches and intake refer to **Appendix-G**.
54. The original certificates of the candidate should not be retained by the institute, under any circumstances. The candidate seeking admission will submit his/her documents/ certificates/testimonials duly attested by the Principal/ Headmaster of the school/ college last attended/ any gazetted officer, if asked by the institute at the time of physically joining the institute.
55. The Director-Principal/ Registrar of the concerned Institute/ University Department shall satisfy him-self/ herself regarding the authenticity of all certificates uploaded online by the candidates for the purpose of their admission in B. Tech. and B. Arch. course and shall be verified online by the institution from the issuing authority of the certificates. The Director-Principal/ Registrar should also ascertain the identity of the candidate by verifying his photo from photo available at <https://techadmissionshry.gov.in>. The Director-Principal/ Registrar of the concerned Institute shall be held responsible for any ineligible admission made in their institute. Anyhow, if the affiliating University, so desires, the original certificates from the candidate can be demanded by the institute at the time of physically joining the institute, of his admission for any purpose whatsoever it may be.
56. For the guidance of candidates, Institute-wise, branch-wise first & last ranks of admission status of the last session 2023-24 would be available on counseling website <https://techadmissionshry.gov.in>.
57. HSTES reserves no right to change the allotment of seat for any particular individual as the allotment is done purely as per the defined counseling procedure/admission guidelines.
58. Post Matric Scholarship (PMS) for SC/ BC will be given to eligible SC/ BC students by the respective Department.

59. Help regarding counseling would be taken from the University Departments, Govt. Engineering Colleges and Government Polytechnics in the State of Haryana for support and guidance of the candidates. Candidates may also contact HSTES at **1800-137-3735 (Toll Free)** or onlineadmissionhelp@gmail.com for any enquiry/ help regarding applying online, counseling fee etc.
60. HSTES does not have any right to change the allotted branch/ college during online counseling. No such request will be considered.
- 61. If the admissions in any branch in Govt. Engineering Colleges (SIETs) are less than 25% in B.Tech. Course, the students of that branch will be shifted to other Govt. Engineering College or branch as per the vacancies and on the basis of directions issued by the Directorate of Technical Education, Haryana.**
62. Always quote your JEE (Main)/NATA Roll No. while making correspondence regarding admission to B.E./B. Tech/B. Arch. courses.
63. The institute shall submit one set of documents self-attested by the admitted candidates (whose details uploaded on HSTES portal last cut off date of Admissions) and duly authenticated by Institute to the concerned affiliating University for authentication and registration purpose. **The concerned affiliating University will further authenticate the documents of the admitted students submitted by the institute after one month of last date admissions for registration of the students.**

CHAPTER-2

GENERAL INFORMATION

1. This Admission Brochure is for admission to B.E. / B. Tech./B. Arch courses for the Academic Year 2024-25 only.
2. Nothing contained in this Admission Brochure should be construed to convey sanction or cited as an authority for which University regulations alone are applicable.
3. The seats in B.E. /B.Tech. Courses in all Government/Private Technical Institutional/State Universities shall be filled against 15% Rest of Haryana Quota (excluding Haryana State) upto 2nd Online Counseling. After 2nd Online counseling all the vacant seats under this Rest of Haryana (RoHC) Category shall be merged in General Category for all the candidates including Haryana, in subsequent counseling.
4. **Two Online-Off-Campus Counseling** will be conducted for admission against B.E./ B. Tech. for all the seats of Govt. University Departments /Govt. Engg. Colleges and 75% seats of Self Financing Institutes only (for details about counseling, refer **chapter 7**) as follows:

1st Counseling - shall be done for all categories namely ROHC, HOGC, HGST, SC, SC-D, BC-A, BC-B, PH, ESM (with all priorities) and FF of all categories with 25% Horizontal Female reservation.

2nd Counseling - shall be done for all categories namely ROHC, HOGC, HGST, SC (by merging SC and SC-D in SC), BC (by merging BCA and BCB in BC), PH, ESM (by merging all priorities) and FF with 25% Horizontal Female reservation.

For the supernumerary seats i.e. Tuition Fee Waiver (TFW), Kashmiri Migrant (KM) and Economically Weaker Section (EWS) seats will be filled separately and with general counseling on the basis of JEE (Main)-2024 rank.

5. **After 2nd counseling, no online counseling shall be conducted by HSTES and admission shall be made at Institute level counseling after merging the sub categories (including female) of a particular reserved category into the main reserved category. In the event of seats remaining vacant/unfilled, if any, same shall be filled up before final cut-off date of admissions without any reservation, firstly on the basis of entrance exam merit and only thereafter on the basis of marks of qualifying examination.**

6. Tuition Fee Waiver (TFW) Counseling shall be done parallel to the general counseling as per AICTE guidelines. Tuition Fee Waiver Scheme of AICTE can be seen at **Appendix-I**. Counseling for KM/EWS shall also be done parallel to the General Counseling.
7. The private unaided institutions shall make admission for B.E/ B. Tech. & B. Arch courses only against 25% of the sanctioned seats (including 15% seats for Children/ Wards of NRI's) at their own level (refer **Chapter 5 & 7**).
8. The admissions made by private institutes at their own level are open for supervision and monitoring of Directorate of Technical Education, Haryana, Haryana State Technical Education Society and Admission & Fee Regulatory Committee (AFRC) constituted by the State Govt. in pursuance of the judgment dated 14.08.2003 of Hon'ble Supreme Court of India in Writ Petition (Civil) No. 350 of 1993 (Islamic Academy & Anr. Vs. State of Karnataka & Ors.).
9. While displaying the status of availability of seats, the number of seats available in a specific branch of an institution will be displayed as per eligibility/category. The non-availability of the seats in a branch of an institution & the seats/institution for which a candidate is not eligible will not be shown to him/her.
10. If a candidate is admitted on the basis of the information submitted by him/her, which is found to be incorrect or false later on, his/her admission shall be cancelled and all fees and other dues paid by him/her shall be forfeited. The HSTES/University/Institute may also take further action, as deemed fit, against the candidate and his/her guardian in accordance with law.
11. If the University authorities are not satisfied with the character, past behavior and antecedents of a candidate, they may refuse to admit him/her in the University/Institute. In order to ensure academic standards, discipline and peaceful atmosphere in the University/Institute, the Vice-Chancellor of the University concerned may cancel the admission of any student for a specified period.

12. Canvassing in any form is strictly prohibited. Further, if any candidate, person or official engages himself/herself in any act that results in the use of unfair means in this counseling, he/she shall be liable to prosecution under relevant law, including the Indian Penal Code. Candidates indulging in any such activity and/or canvassing may also be denied admission.
- 13. Candidates seeking admission in private unaided institutions are advised to ensure that they are lawfully admitted failing which, they shall not be authenticated by the HSTES and shall not be registered by the affiliating Universities and they themselves shall be responsible for any such lapse.**
14. The decision of the Haryana State Technical Education Society (HSTES) in all matters relating to the admissions shall be final.
15. All disputes pertaining to counseling for making admissions to B.E. / B. Tech./B. Arch Courses for the session 2024-25 are subject to the jurisdiction of Panchkula only. The Haryana State Technical Education Society (HSTES) shall be the legal authority in whose name the State may sue or may be sued for this purpose. No suit, prosecution or other legal proceedings shall lie against the State of Haryana or any officer of the State Govt. or the NIC or Haryana State Technical Education Society, for anything which is in good faith done or intended to be done for the purpose of on-line off-campus counseling.
16. All the rules and regulations for submission of migration certificate by the candidates who have passed the qualifying examinations from other Universities/ Boards will be applicable as per the rules of the concerned university.
17. Ragging in educational institutions is banned and any one indulging in ragging is likely to be punished appropriately, which may include expulsion from the institution, suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take the shape of
- i. Withholding scholarships or other benefits
 - ii. Debarring from representation in events
 - iii. Withholding results

iv. Suspension or expulsion from hostel or mess, and the like.

If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded to act as a deterrent.

The Technical Institutions shall follow Prevention and Prohibition of Ragging as provided in the Appendix 12 of the Approval Process Handbook 2024-25 by AICTE. The following will be termed as the acts of ragging vide UGC regulations 29.06.2016 and AICTE approval process handbook 2024-25:

“(j) any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of color, race, religion, caste ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic, identity, place of birth, place of residence or economic background.”

2. For Kashmiri Migrants relaxation in cut-off percentage upto 10% subject to the minimum eligibility requirement in B.E./B. Tech. Kashmiri Migrant are required to fill Online Application Form on website: <https://techadmissionshry.gov.in>.

Note for B.Tech. (Bio-Tech.):-

In UIET, Maharshi Dayanand University, Rohtak and in UIET, Kurukshetra University, Kurukshetra 40 seats of B. Tech (Biotechnology Engg.) from PCB students and 20 seats

from JEE Main or on the merit of qualifying examination with Physics, Chemistry & Maths as major subject will be reserved. The criteria for filling of 40 seats of the B. Tech. (Biotechnology) from students who studied PCB in their qualifying exam and 20 seats from JEE main rank or on the merit of qualifying examination with Physics, Chemistry & Maths as major subjects in UIET MDU Rohtak & UIET, KUK. Further, in the last manual counseling the vacant seats may be merged and may be filled up by institute as per the eligibility criteria on the basis of JEE main rank or on the merit of qualifying examination with the subjects mentioned at Serial No. 5 of above given table.

3.2 Kashmiri Migrants (KM), Haryana Govt. School Topper (HGST), Tuition Fee Waiver (TFW) and Economically Weaker Sections (EWSs) seats in B.E./B.Tech. courses:

- **Minimum Academic Qualification shall be same as mentioned in section 3.1.**

Basis of admission:

- A. **Kashmiri Migrants** seats (5% of sanctioned intake of each course) for B.E. /B. Tech. will be supernumerary seats and will be filled on the basis of All India Rank of JEE Mains 2024 conducted by the NTA. Kashmiri Migrants will be required to have the original certificate of Migration duly signed by the competent authority or Relief commissioner.

Note for Kashmiri Migrant:

1. KM category candidate shall apply online and the application/registration fee for the purpose shall also be deposited online on <https://techadmissionshry.gov.in> through Credit/Debit Card or Net banking by using online payment gateway. Candidate shall upload proof of Date of Birth, Migration Certificate duly signed by Competent Authority or Relief Commissioner (PDF of Max. 100 KB Size for each document), recent passport size Colored Photograph (JPG File Max. 30KB Size) and Specimen Signature (JPG File Max. 20KB Size) on online application form on website <https://techadmissionshry.gov.in>.
2. If original document of Detailed Marks Certificate (DMC) of qualifying exam is available then upload original document and if document downloaded online then take a printout of the same and upload after self-attesting it on Online Application Form. The uploaded documents should be neat and in readable form.

3. The Migration Certificate duly signed by competent authority or Relief Commissioner shall be uploaded by the candidate at the time of registration for online centralized counseling along-with other relevant documents, otherwise allotted seat will be cancelled by the reporting institute.
4. Aadhaar Number (or Enrolment Number), It has been decided by the Government that from the session 2019-20 onwards, the candidate shall submit preferably the Aadhaar Number (or Enrolment No.) at the time of online registration.
5. The candidates applying under Kashmiri Migrants (KM) will produce a certificate in the support of their claim from the competent authority or Relief Commissioner.
6. Candidate, if any, simultaneously applying for all options i.e. through JEE (MAIN)-2024 for B.E./B. Tech. 2024 as well as under Kashmiri Migrants (KM) Quota are required to deposit the one time registration fee i.e. Rs. 700/- (non-refundable), through <https://techadmissionshry.gov.in> for submitting Application Forms. The KM candidate has to participate in Online Off-campus counseling on website <https://techadmissionshry.gov.in>, separately for each category with their KM roll number and with their JEE Main roll number. The separate seat allotment will be issued for both categories.
7. Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.

B. Haryana Govt. School Topper (HGST), seats in each branch in the Govt./ Aided/ University Department/ Private Institutes offering B.E. /B.Tech. Programme shall be filled on the basis of All India Rank of JEE Mains 2024 out of each topper (having Minimum 2nd division i.e. 50% marks in aggregate) of Govt. Senior Secondary School offering Science Stream for the session 2023-24 only (Having Minimum 05 students on roll in the Science stream), subject to fulfilling the eligibility criteria. The candidate shall produce a certificate in the support of their claim from the Principal/Headmaster of the Govt. School of which the candidate is topper clearly stating the strength of class **(Annexure-X)**.

a.) Approved Conditions for Haryana Govt. School Topper(HGST) in B.Tech as follows:

1. The candidate should have minimum 2nd Div. i.e. 50% marks in aggregate, in qualifying exam.
2. The Govt. Senior Secondary School offering Science Stream of 2023-24 should have minimum 05 students on roll in their Science stream.

3. The candidates shall produce a certificate in support of their claim issued by the Principal/Headmaster of the Govt. School from where the candidate has passed his qualifying exam and the candidate is topper of his school, clearly mentioning the strength of the school in Science stream (**Annexure-X**).

Note: Only toppers of Govt. Senior Secondary School offering Science Stream of 2023-24 are eligible and passed in 2024 only. Seat reserved for HGST is within the sanctioned intake.

NOTE for HGST:

- a. Candidates applying to HGST Category in B.E. /B. Tech. shall upload his/her Detailed Marks Certificate of Qualifying exam, proof of Date of Birth, certificate from the Principal of the Govt. School of Haryana of which the candidate is topper (PDF of Max. 100 KB Size for each document), recent passport size Colored Photograph (JPG File Max. 30KB Size) and Specimen Signature (JPG File Max. 20KB Size) on online application form on website <https://techadmissionshry.gov.in>.
- b. If original documents available then upload original document and if document downloaded online then take a printout of the same and upload after self-attesting it on Online Application Form.
- c. However, the Certificate from the Principal of the Govt. School of Haryana of which the candidate is Topper, clearly stating the strength of class and the candidate claiming HGST quota should be Topper (minimum 2nd division) in current year exam (i.e.-2023-24). (Minimum strength of class should be 5 to become eligible for HGST) as given in **Annexure-X** along-with other documents shall be uploaded by the candidate at the time of registration for centralized online counseling, otherwise allotted seat will be cancelled by the reporting institute:

C. Tuition Fee Waiver seats for B.E. /B. Tech:-

Under this Scheme, up to a maximum of 5% of “Approved Intake” per Course shall be available for this admission. These seats shall be supernumerary in nature. These supernumerary seats shall be available only to such Course(s) in an Institution, where a minimum of 50% of “Approved Intake” are filled up in last academic year. Sons/ Daughters of parents whose annual income is less than **Rs.8.00 Lac from all sources**

as verified from their PPP ID, shall only be eligible for seats under this scheme (as per Appendix-I).

The Annual income from all sources of the Parents/family of the candidates applying for Tuition Fee waiver Scheme does not exceed Rs.8.00 lakh and should be verified from PPP ID Database.

NOTE for TFW:

1. Candidate applying to TFW category in B. Tech. are required to opt the TFW category at the time of registration online on <https://techadmissionshry.gov.in>.
2. If original documents available then upload original document and if document downloaded online then take a printout of the same and upload after self-attesting it on Online Application Form.
3. However, the following certificates issued by competent authority along-with other relevant documents shall be uploaded by the candidate at the time of registration for centralized online counseling otherwise allotted seat will be cancelled by the reporting institute:
 - a) PPP ID No. is mandatory for registering for TFW Category.
 - b) Only those candidates whose parental/Guardians annual income from all sources does not exceed Rs. 8.00 Lacs can apply for TFW category by verifying their annual income from their PPP ID as per the State Govt. Instructions dated 31.08.2022.
 - c) Aadhaar Number (Or Enrolment Number). It has been decided by the Government that from the session 2019-20 onwards, the candidate shall submit preferably the Aadhaar Number (or Enrolment No.) at the time of online registration

D. Economically Weaker Sections (EWS):-

The Economically Weaker Sections (EWS) seats are supernumerary in nature and will be filled separately on the basis of All India Rank of JEE Main-2024. EWS seats are 10 percent of the sanctioned intake per course shall be available in all educational institutions other than the minority educational institutions approved by AICTE.

1. The following certificates issued by competent authority along-with other relevant documents shall be uploaded by the candidate at the time of registration for

centralized online counseling, otherwise allotted seat will be cancelled by the reporting institute:

- i. EWS Income and Asset Certificate (issued by Tehsildar of the area where the applicant normally resides) (Given at **Appendix-J**). However, the family income of the candidate should be matched & verified from his/her PPP ID.
2. If original documents available then upload original document and if document downloaded online then take a printout of the same and upload it after self-attesting at the time of registration for Online Centralized Counseling. The uploaded document should be neat and in readable form.

E. "HARIHAR" (Homeless, Abandoned and Surrendered Children Rehabilitation Initiative Haryana) Policy:

The Women & Child Development Department Haryana has notified "HARIHAR" (Homeless, Abandoned and Surrendered Children Rehabilitation Initiative Haryana) policy vide notification no. 111 DW (3) dated 20.07.2021 with the aim to provide Education, Financial and Employment benefits to the Abandoned and Surrendered Children who have completed the age of 18 years from the Child Care Institutions of the State and were abandoned before the age of 5 years or surrendered before the age of 1 year.

1. As per the guidelines issued vide memo no. 294-338/ Academic dated 09.09.2021 (**Appendix-J**) such candidates of HARIHAR Category having Economically Weaker Section (EWS) status shall also be considered under EWS category for admission to Technical institutions in all Government/ Society mode and Government-Aided Institutions (SIETs/ State Technical Universities) under the ambit of Technical Education Department.
2. The candidates belonging to HARIHAR category approved by the concerned District Approval Committee shall apply online on <https://techadmissionshry.gov.in> for admission to the B.Tech. against the Open / EWS category seats from the session 2024-25.
3. In case of institute level admissions, the institute level committee constituted for EWS/TFW candidates will also make admissions of such candidates after verifying the certificate issued by District Approval Committee as per the merit against the Open / EWS category seats. All Government institutes is hereby issued vide memo no. 294-338/ Academic dated 09.09.2021 to consider such candidates under "HARIHAR" Policy for providing free education to such candidates after verifying all the documents as per the guidelines issued by the Directorate to the institutions for implementation of the scheme / notification of the Department.

Note:

- Candidates, if any, simultaneously applying for B. Tech as per his / her category and also through TFW /EWS are required to deposit one time registration fee through <https://techadmissionshry.gov.in>.
- Submission of duplicate applications is not allowed. In case, duplicate application found, all the applications of such candidate will be cancelled automatically.
- For detailed procedure regarding counseling kindly read **Chapter-7**.

3.3 Minimum Academic Qualification for B. Arch.:-

(*Subject to change as per guidelines/directions of COA and State Govt.).

- No candidate shall be admitted to architecture course unless he has passed an examination at the end of the 10+2 scheme of examination with at least 50 per cent. Aggregate marks in Physics, Chemistry and Mathematics and also at least 50 per cent marks in aggregate of the 10+2 level examination or passed 10+3 Diploma Examination with Mathematics# as compulsory subject with at least 50 percent marks in aggregate.
- # Students passed Diploma Architecture through Lateral Entry, who have not passed mathematics as one of the subject, are not eligible for admission in B.Arch.
- The candidate needs to qualify an Aptitude Test in Architecture either NATA-2024 conducted by the Council of Architecture (COA) or any other aptitude test recognized by the COA.
- The institutions shall give weightage of 50 percent marks for aptitude tests and 50 percent marks in the Qualifying examination as provided in sub-regulation (1), in the matter of admissions.

a. Basis of admission for B. Arch:

Admission shall be made on the basis of Architecture aptitude test "NATA" conducted by the Council of Architecture (COA) or any other aptitude test recognized by the COA and merit lists may be prepared on the basis of aggregate marks of 10+2 and NATA-2024 score (percentile) or score (percentile) of any other aptitude test recognized by the COA in the ratio 50:50.

b. Tie breaking criteria for B. Arch:

The following under mentioned criteria will be followed to break-up the tie:

- i. Candidate getting higher marks in Mathematics shall rank higher in order of merit.
 - ii. If tie still persists, candidate getting higher marks in English shall rank higher in order of merit.
 - iii. If tie still persists, senior in age will rank higher in order of merit.
 - iv. If tie still persists, the candidate whose name appears first in alphabetical order (in English as mentioned in qualifying examination mark sheet) shall rank higher in order of merit.
 - v. If tie still persists, the Father's Name of the candidate whose name appears first in alphabetical order (in English as mentioned in qualifying examination mark sheet) shall rank higher in order of merit.
 - vi. If tie still persists, the Mother's Name of the candidate whose name appears first in alphabetical order (in English as mentioned in qualifying examination mark sheet) shall rank higher in order of merit.
- c. Under **Economically Weaker Sections (EWSs)** will be supernumerary seats and will be filled separately on the basis mentioned in "a" above, seats up to maximum 10 percent of the sanctioned intake per course shall be available in all educational institutions other than the minority educational institutions approved by C.O.A. These seats shall be supernumerary in nature (***Subject to change as per guidelines/directions of COA and State Govt.**).
1. **The admission seeker for B. Arch. Course** need to apply online at <https://techadmissionshry.gov.in>. and shall upload his/her Score card of NATA -2024 (PDF of Max 100 KB Size), detailed marks certificate of Qualifying exam (PDF of Max 100 KB Size) and EWS income & Asset Certificate issued by Tehsildar of area (Detail given at **Appendix-J**), on online application form on the website <https://techadmissionshry.gov.in>.
 2. **However, the following certificates shall also be required at the time of reporting to the Institute; otherwise allotted seat will be cancelled automatically by the reporting institute.**
 - i. Detailed Mark Certificate of qualifying exam.
 - ii. Valid NATA-2024 score card/ any other aptitude test recognized by the COA.
 - iii. PPP ID No.

- iv. Aadhaar Number (or Enrolment Number). It has been decided by the Government that from the session 2019-20 onwards, the candidate shall submit preferably the Aadhaar Number (or Enrolment No.) at the time of online registration.
- v. EWS Income and Asset Certificate (issued by Tehsildar of the area where the applicant normally resides) (Given at **Appendix-J**).

Note:

1. Mere possession of the prescribed academic qualifications does not entitle a candidate for admission to B.E./B. Tech./B. Arch course. Candidates would be required to fulfill other conditions as spelt out in the Admission Brochure.
2. Candidates, who are appearing in the qualifying examination this year and are expecting to pass the same, can also compete for counseling for B.E./B. Tech.
3. It will be the responsibility of the candidate to ensure eligibility for admission before applying for the course. If on verification at any stage, it is found that a candidate does not fulfill the eligibility conditions, his/her candidature will be cancelled and the fee deposited by him/her shall be forfeited.
4. Candidate if any simultaneously applying for more than one option i.e. JEE-MAIN-2024, Haryana Govt. School Toppers (HGST), Kashmiri Migrants (KM) Quota, Economically Weaker Sections (EWSs) and Tuition Fee Waiver Category quota are required to opt his/her category during applying online at <https://techadmissionshry.gov.in>.
5. The candidates having "HARIHAR" certificate may be consider under Open and EWS Category seats for admission in B.E./B.Tech. Course in Govt./Govt. University Institutions at institute level also.

A separate Roll No. will be issued through this site and for that category the counseling will be done by that Roll No. only. After the display of Rank / Inter-se-Merit, candidate has to participate in Online Off-campus counseling on <https://techadmissionshry.gov.in>, separately for each category.

CHAPTER-4

INFORMATION REGARDING INTAKE FOR THE SESSION 2024-25

1. Institute-wise, branch-wise sanction intake for the session 2024-25 will be incorporated in the admission brochure after receiving the same from concerned branch of Directorate (**Appendix-G**).
2. Institutions/disciplines/intake is subject to change by the competent authority. New institutions/disciplines and the variation of intake in the existing institutions shall be considered for admission for the year 2024-25, if the approval from the competent authority such as AICTE/COA/Affiliating University/DTE is received before the start of counseling.
3. Seats upto 5% of sanctioned intake per course in all Govt. /University Departments/ Engg. Colleges/ Self-Financing Institutes are reserved for **Kashmiri Migrants** for admission in 1st semester in B.E. /B. Tech, as per guidelines of AICTE for the session 2024-25. These seats are supernumerary in nature.
4. For **Haryana Govt. School Topper (HGST)**: One seat is reserved in each course/discipline in every institute for admission of toppers of science stream 2024 (having minimum 2nd division) of Govt. High Schools of Haryana (having minimum 5 students on roll in the Science stream), for admission in 1st semester in B.E. /B. Tech. Seat reserved for HGST is within the sanctioned intake.
5. The Institutes opting for **Tuition Fee Waiver (TFW)** scheme in B.E./B.Tech. are permitted to fill the seats upto 5% of the total sanctioned intake per course in the institutions approved by AICTE. These seats are supernumerary in nature and will be available to such courses in an institute, where a minimum of 50% of sanctioned seats are filled up in last academic year. These seats shall be filled through online counseling.
6. Under **Economically Weaker Sections (EWSs)** in B.E./B.Tech. & B.Arch., will be supernumerary seats and will be filled separately on the basis of Rank of JEE Main-2024 (in case of B.E./B.Tech.) and merit prepared on the base of 10+2 & NATA-2024/ or any other test recognized by CoA score in 50:50(in case of B.Arch.), seats up to

maximum 10 percent of the sanctioned intake per course shall be available in all educational institutions other than the minority educational institutions approved by AICTE. (***Subject to change as per guidelines/directions of AICTE/COA and State Govt.**).

7. Under **HARIHAR (Homeless, Abandoned and Surrendered Children Rehabilitation Initiative Haryana)** in B.E./B.Tech. Course such candidates of HARIHAR Category having Economically Weaker Section (EWS) status shall also be considered under Open /EWS category for admission to Technical institutions in all Government and Government-Aided Institutions (SIETs/ State Technical Universities) under the ambit of Technical Education Department as per memo no. 294-338/ Academic dated 09.09.2021 (**Annexure-J**)

Note: The candidates are advised to check the approval of All India Council for Technical Education (AICTE) and concerned university for a particular branch of B. Tech. course of any institute from the website of AICTE and affiliating University. In case of B. Arch, candidates are advised to check the approval of Council of Architecture (COA) from the website of COA and the affiliating University.

CHAPTER-5
DISTRIBUTION OF SEATS

5.1 For Govt./ Self-Financing: The Reservation policy notified by the State Government of Haryana is applicable for admissions in Technical Education Institutions for the session 2024-25:

***In case of SC category the condition of 50% of 20% to Scheduled Castes and 50% of 20% to Scheduled Deprived Castes (as mentioned above) is applicable only for reservation in Admission In Government Educational Institutions**

In the event of quota reserved for physically handicapped remain unutilized due to non-availability for suitable category of handicapped candidates, it may be offered to the Ex-serviceman and their wards (1%) and the dependents of freedom Fighters (1%).

Further 3% horizontal reservation is also provided to Ex-servicemen/Freedom Fighters and their dependents by providing reservation within reservation of 1% of general category, 1% out of Scheduled Castes and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided/institutes located in Haryana. As far as block allocation in Block-A and Block-B of Backward Classes category is concerned, year-wise rotational system will be adopted. For example, if Block A of Backward Classes are given seats in the academic year 2006, the next block i.e. B Block of category of Backward Classes will be given seats in the next academic year i.e. 2007 and so on.

As far as seat allocation in SC and Deprived SC of Scheduled Castes category is concerned, year-wise rotational system will be adopted for Ex-servicemen/ Freedom Fighter and their dependents. For example, if seat given to SC of Scheduled Castes in the academic year 2020-21, then seat will be given to the Deprived SC of Scheduled Castes in the next academic year i.e. 2021-22 and so on.

Instructions vide Notification No.22/27/2019-1GS-III dated 04.06.2020 issued by the GS-III Branch of Govt. of Haryana for Haryana Scheduled Castes will be implemented as follows: "Fifty percent of the twenty percent seats reserved for Scheduled Castes for admission in any Government educational institution shall be set aside for candidates belonging to deprived Scheduled Castes as enumerated in the **Appendix-C1**.

Where a seat is set aside for candidate from the deprived Scheduled Castes for admission in Government Educational Institution is not filled up in any academic year due to non-availability of candidate of the deprived Scheduled Castes possessing the requisite qualification, the same shall be made available to the candidate of Schedule Castes." (List of Scheduled Castes is at **Appendix-C** and Deprived Scheduled Castes are at **Appendix-C1**).

The seats in B.E./B.Tech Courses in all Government/ Private Technical Institutions/ State Universities for the session 2024-25 shall be filled against 15% Rest of Haryana Quota (excluding Haryana State) upto 2nd Online Counseling. **After 2nd Online Counseling all the vacant seats under this Rest of Haryana Category (RoHC) shall be made in General Category to all the candidates including Haryana in subsequent counseling.**

Under **Economically Weaker Sections (EWSs)**, these seats will be supernumerary seats and will be filled separately on the basis of All India rank obtained in JEE-Mains 2024 for B.E./B.Tech. as thereafter on the basis of inter-se-merit of qualifying examination, seats up to maximum 10 percent of the sanctioned intake per course shall be available in all educational institutions other than the minority educational institutions approved by AICTE. These seats shall be supernumerary in nature. In case of B.Arch. EWS seats will be filled on the basis of merit prepared from score (percentile) of valid NATA-2024/ **any other aptitude test** & marks of qualifying exam in 50:50 as per COA. (***Subject to change as per guidelines/directions of AICTE/COA and State Govt.**).

Important Note:

- 25 % horizontal reservation in all categories except in supernumerary seats shall be provided for girl candidates.
- Haryana Govt. Senior Secondary School Topper (HGST):- One seat in each branch discipline of B.Tech. course in every institute is reserved for topper of 10+2 within sanctioned intake (Science stream of year 2024 having minimum 2nd division).

5.2 For Private Unaided Institutions:

➤ **The sanctioned intake in Private Unaided Institutions for B.Tech. Course shall be distributed as under:-**

- The institutions shall fill 25% of sanctioned intake (management quota) of their AICTE approved B.E./B. Tech course at their own level firstly on the basis of All India Rank obtained in JEE (MAIN)-2024 and thereafter on the basis of merit of marks secured in qualifying examination in a fair and transparent manner.
- 75% of sanctioned intake shall be filled through HSTES.

Note:- The admissions of 75% of sanctioned intake in Private Unaided Institutes shall be done by HSTES as per the Reservation Policy notified by the State Government of Haryana.

➤ **The sanctioned intake in Private Unaided Institutions for B.Arch. course shall be distributed as under:-**

- i. The institute shall fill their 25% seats of sanctioned intake (management quota) at their own level.
- ii. 75% of sanctioned intake shall be filled through HSTES.

Note:-The admissions of 75% of sanctioned intake in Private Unaided Institutes shall be done by HSTES from Haryana resident and All India Open (AIO) category candidates as per the State Reservation Policy in counseling.

5.3. For private unaided Minority institutions:-

- i. Rest of Haryana Category (RoHC)(Excluding Haryana State)including NRI seats not exceeding upto 15% (at the discretion of the management as above).

- ii. Minority Quota- 42.5% of sanctioned intake fixed by the State Govt. vide notification No. 20/5/2004-4TE, dated 25.06.2004.
- iii. Balance – 42.5% (half for Haryana Open General and half for reserved categories of Haryana in the ratio as specified above).

5.4. Special Reservation in Institute of Urban Planning and Architecture, Dada Lakhmi Chand State University of Performing and Visual Arts, Rohtak.:-

2. **State reservation policy at the time of counseling (for preparation of seat matrix) shall be followed.**
3. 25% horizontal reservation in all above categories shall be provided for girl students.
4. The reservation policy is to be implemented as per existing State Government Policy.
5. Vacant seats if any against reserved categories will be offered to General Category aspirants on the basis of merit.

Note:

1. Change, if any, shall be applicable at the time of counseling.
 - i. The seats in B.E. /B. Tech Courses in all Government/Private Technical Institutions/State Universities shall be filled against 15% Rest of Haryana Quota (excluding Haryana State) upto 2nd Online Counseling. After 2nd Online Counseling all the vacant seats under this Rest of Haryana Category (RoHC) shall be made in General Category to all the candidates including Haryana in subsequent counseling at institution level. If the candidate does not have their PPP ID, may apply for RoHC Category and are required to produce any of the

following for the consideration in Resident of other than Haryana State Category (RoHC):

- i. Other State "Domicile Certificate" issued by Competent Authority of other State.
- ii. 10+2 or Latest Qualification Proof from State Other than Haryana.
- iii. Affidavit from the parents working as Govt. Employee in State other than the Haryana State.

Note: The RoHC being exclusive reservation, the candidate are not allowed to apply in Haryana Category.

2. For B.E. /B. Tech Courses, 10 (Ten) seats are reserved for the Bonafide residents of Murthal in DCR University of Science & Technology, Murthal (Sonapat). So these will be filed strictly in accordance with the relevant decision of Hon'ble Punjab and Haryana High Court Civil Writ Petition No. 1382 of 2003 & 10 (Ten) seats in CDLM Engg. College, Panniwala Mota, Sirsa for residents of Village Panniwala Mota. These seats shall be filled by the respective institutes on merit by giving due publicity at their own level before 2nd phase of counseling.
3. For B.E. /B. Tech Courses, 8 seats (2 seats in each branch) are reserved in Matu Ram Institute of Engg. & Mgmt., Rohtak for the residents of Bohar/ Garhi and migrated residents of these villages to Kutana/ Majra. All admissions shall be made firstly on the merit of JEE (Main) and vacant seats if any, shall be filled on the merit of qualifying exam by the Director-Principal at their own level in transparent manner by giving due publicity.
4. For B.E. /B. Tech Courses, 8 seats (2 seats in each branch) are reserved in JMIT Radaur for the residents of Chhotabans. All admissions shall be made firstly on the merit of JEE(Main) and vacant seats if any, shall be filled on the merit of qualifying exam by the Director-Principal at their own level in transparent manner by giving due publicity.
5. Only the candidates having the permanent disability of not less than 40% (being otherwise fit for admission to the course) will be considered for admission as Physically Handicapped. Disability certificate must be issued from Chief Medical

Officer of the concerned District. However, the certificate shall be subject to verification by a Medical Board constituted by the affiliating university for the purpose. The decision of the Board shall be final. Physically Handicapped candidates belonging to Haryana are required to submit the handicap certificate as per **Annexure-III** at the time of Reporting and same should be updated/ verified on the PPP portal also.

6. Merging of sub-categories in the reserved categories and removal of ESM priorities of Haryana shall be made before 2nd online off-campus counseling. The vacant seats of reserved categories of Haryana shall be converted and offered to General Category Candidate's alongwith other net resultant in the subsequent counseling.
7. Candidates claiming reservation are required to update and verify their category in PPP ID Data as the category of the candidates should be matched and verified from their PPP ID during applying online.
8. The parents of BC candidates (Block A & B) for benefit of reservation for their ward shall have to verify their annual family income verified from their PPP ID during applying online to the effect that they does not fall under the creamy layer at the time of admission as per notification no. No. 491-SW (1)-2021 dated 17 November, 2021.
9. Children & Grand-children of Freedom Fighters of Haryana are required to upload a certificate from the Deputy Commissioner of the concerned District as per **Annexure-IV** at the time of registration.
10. The seats reserved for ESM category shall be offered in order of following priorities:
 - I. Widows/Wards of Defence personnel killed in action.
 - II. Wards of disabled in action and boarded out from service.
 - III. Widows/Wards of Defence personnel who died while in service with death attributable to military service.
 - IV. Wards of disabled in service and boarded out with disability attributable to military service.
 - V. Wards of Ex-Servicemen who are in receipt of Gallantry Awards:-
 - Param Vir Chakra
 - Ashok Chakra

- Sarvottam Yudh Seva Medal
- Maha Vir Chakra
- Kirti Chakra
- Uttam Yudh Seva Medal
- Vir Chakra
- Shaurya Chakra
- Yudh Seva Medal
- Sena, Nau Sena, Vayu Sena Medal
- Mention-in-Despatches

VI. Wards of Ex-Servicemen

So, the candidates claiming reservation for these categories of Haryana are required to submit the certificate as per **Annexure-V** in case of deceased/disabled and **Annexure-VI** in case of THE EX-EMPLOYEES OF INDIAN DEFENCE SERVICES/PARA-MILITARY FORCES, whichever is applicable, at the time of counseling.

11. If the number of seats in any particular category is not a round figure, 0.5 or above will be taken as one and less than 0.5 shall be ignored, except that in Physically Handicapped, Children & Grand-children of Freedom Fighters and Ex-Servicemen and their Wards Categories, at least one candidate will be admitted from all the three categories in total, even if the share is less than 0.5 seats provided the number of sanctioned intake in the particular course is 30 or above. However, seat distribution will be done by the software as provided by NIC.

12. A candidate, who applies for reserved category will be considered first in general category. In case, he/she does not get a seat of his/her choice in general category, then he/she will be considered for reserved category as applicable. The category of allotted seat may be higher than the actual category of the candidate.

5.5 NRI Quota Seats:

In compliance of the judgment dated 12.08.2005 of Hon'ble Supreme Court of India in PA Inamdar case, a limited reservation of NRI Seats, not exceeding 15%, may be made available to NRIs depending on the discretion of the Management subject to two conditions:

1. Such seats should be utilized Bonafide by the NRIs only and for their children or wards.
2. Secondly, within the quota, the merit should not be given a complete go-by.
 - (a) The amount of money, in whatever form collected from such NRIs, should be utilized for benefitting students such as from economically weaker sections of the society, whom, on well-defined criteria, the educational institutions may admit on subsidized payment of their fee.
 - (b) To prevent mis-utilization of such quota or any malpractice referable to NRI quota seats, it will be for the committees constituted pursuant to Islamic Academy's direction i.e. under the Chairmanship of Hon'ble Mr. Justice R.K. Nehru (Retd.) to regulate till suitable legislation or regulations are framed by the state.
 - (c) List of institutions offering NRI seats and their fee structure shall be made available in due course of time.

Note:

- i. Students in their own interest, are advised to seek admission against NRI seats only, if they fulfill the eligibility and other conditions prescribed in Hon'ble Supreme Court decision in PA Inamdar case, failing which, it is most likely that their admission may be cancelled at any later stage, whenever, comes to the notice of the competent authority.
- ii. Counseling for NRI seats, if any, shall be strictly done by the concerned institute at their own level as per the counseling schedule mentioned in key dates and strictly as per guidelines of Hon'ble Supreme Court Decision in PA Inamdar case.
- iii. Eligibility for such seats shall remain the same as mentioned in Chapter-3. Anyhow, the candidates passing qualifying exam, from foreign countries shall produce the equivalency certificate from the association of Indian University. Such seats shall be filled on the basis of inter-se-merit of qualifying exam.
- iv. The fee shall be charged, as devised by the concerned institute and determined by State Fee Committee. However, it is made clear that no institute shall charge more or less fee than determined by the State Fee Committee.
- v. Applications shall be invited by the concerned institute for NRI Quota seats at their own level and the merit list of such candidates admitted by the Institute shall be

displayed on the institute's website by the institute before final cut-off date of all admissions with copy to affiliating University, Haryana State Technical Education Society and Chairman, Admission Fee & Regularity Committee in the following format:

- vi. The institutes must update their NRI admissions online on the website www.intrahstes.gov.in before final cut-off date of all admissions mentioned in "Key Dates".

CHAPTER- 6

INFORMATION REGARDING FEE

In pursuance of the judgment dated August 14, 2003 of Hon'ble Supreme Court of India in writ petition (Civil) No.350 of 1993 (Islamic Academy and Anr. Vs. State of Karnataka and Ors.), the State Government had constituted Chairman, Admission Fee & Regularity Committee to fix fee structure of private unaided minority/non-minority institutions for various types of technical courses. The Supreme Court guidelines stipulate that fee structure should be such that it is viable for the Colleges to function as per norms laid down by AICTE, but there should be no profiteering.

The Fee structure of various self-financing technical institutions is available at **Appendix-F** and on the website <https://afrchry.techeduhry.gov.in> & www.techeduhry.gov.in. Candidates are advised to see the changes, if any, in the fee structure of institutes on the website www.techeduhry.gov.in before filling the choices of branch and institutes during online counseling as there may be pending requests with Admission and Fee Regulatory Committee from some institutes for fee revision.

Guidelines issued by Admission and Fee Regulatory Committee, Haryana regarding charging of different amounts under various heads other than Tuition Fee, Development fund, Student fund, Caution Money.

4. **Hostel & Mess charges:** Maximum ₹2000/- P.M. per student for ordinary room and maximum ₹2500/- P.M. for AC Room per student. Mess Charges will be as per actual expenses on breakfast, lunch, evening tea and dinner. The Institute will pass a specific order in this regard and display it on the notice board and its website. Boarding and lodging shall include water & electricity, reading room, computer centre, gym and sports/necessary furniture & furnishings. However there can be a variation of 10% depending upon locale and specific demands. Laundry and Canteen etc. shall be on actual basis and optional.
5. **Transport:-** It has to be as per actual, however not beyond Govt. fare per km. + up to 50%.
6. **University/Board and Examination fee-** as per actual.
7. **Prospectus:-** only once in the course and should not be more than Rs.1000/-.
8. **Placement Brochure:-** Chargeable only once (in final year) and should not be more than Rs.750/-.
9. **Insurance:-** Actual basis.
10. **Uniform:-** If prescribed and supplied by the institute /university Rs.6000/- which shall include one Blazer, two trousers, two shirts, one tie, two socks. Other requirements, if any shall be optional and chargeable.

Every institute is required to fix all the charges accordingly and reflect in their prospectus & on their website and must necessarily submit a copy of prospectus and placement brochure to Admission and Fee Regulatory Committee before start of Admission process every year.

CHAPTER-7
IMPORTANT PROCEDURES FOR SESSION 2024-25

7.1 PROCEDURAL STEPS FOR PARTICIPATING IN ONLINE OFF CAMPUS COUNSELING AND CHOICE FILLING

1. This procedure is applicable for the candidates who want to take admissions through online counseling.
2. Candidates should go through information brochure for gathering detailed information about counseling schedule and procedure. Softcopy is available on the websites www.hstes.org.in
3. The candidate who has registered/sign up on <https://techadmissionshry.gov.in> for B.Tech. Course as per the eligibility mentioned in the **Chapter-3** and paid the registration fees, can participate in the Online Off Campus Counseling's by filling of order of choices by sign in the website by using their credentials as per the key dates.
4. The seats in B.E./B.Tech. Courses in all Government/Private Technical Institutions/State Universities shall be filled against 15% Rest of Haryana Quota (excluding Haryana State) upto 2nd Online Counseling. After 2nd Online Counseling all the vacant seats under this Rest of Haryana Category (RoHC) shall be made in General Category to all the candidates including Haryana in subsequent counseling.
5. **Two online counseling** will be conducted for admission to B. Tech. course for all the seats of University Departments, Govt./Govt. Aided Institutions and 75% seats of Self Financing Institutes as follows:
 - 1stcounseling:** shall be done for all categories namely RoHC, HOGC, HGST, SC, SC-D, BC-A, BC-B, PH, ESM (with all priorities) and FF of all categories with 25% Horizontal Female reservation.
 - 2nd counseling:** shall be done for all categories namely RoHC, HOGC, HGST, SC (by merging SC and SC-D in SC), BC (by merging BCA and BCB in BC) and merging all ESM (all priorities) and FF with 25% Horizontal Female reservation.

For the supernumerary seats i.e. Kashmiri Migrants (KM), Tuition Fee Waiver (TFW) and Economically Weaker Section (EWS) seats, online counseling will be done parallel to above counseling on the basis of JEE (Main)-2024 rank.

6. After 2nd counseling no online counseling shall be conducted by HSTES and admission shall be made at Institute level counseling after merging the sub categories (including female) of a particular reserved category into the main reserved category. In event of seats remaining vacant/unfilled, if any, same shall be filled up before final cut-off date of admissions without any reservation, firstly on the basis of entrance exam merit and only thereafter on the basis of marks of qualifying examination.

Steps for Participating in Online Counseling:

1. For participation in online counseling (ID Verification, registration, submission of choices, downloading of seat allotment letters etc.), candidate will visit the website <https://techadmissionshry.gov.in> from any internet point preferably from any of the technical institutions in the states . **(Avoid going to Cybercafés, as they may mislead or misguide you).**
2. On website, <https://techadmissionshry.gov.in>, view general information about institutions profile, cut off ranks, latest schedules of counseling etc.
3. **The candidate who has registered/sign up on <https://techadmissionshry.gov.in> for B.Tech. Course as per the eligibility mentioned in the Chapter-3 and fill the required details and paid the registration fees, To start counseling “click here to Log in/ Sign in” option and submit your details of Course, PPP ID, Registration ID (as per JEE-Main admit card in case of B.E./B. Tech. Course and admit card of NATA-2024/ any other aptitude test recognized by the COA in case of B. Arch. Course) OR details provided by HSTES and password.**
4. **The fresh candidates in B.Tech. Course can sign up on the <https://techadmissionshry.gov.in> for new registration “click here to Register/ Sign-Up” option and submit your details of Course, JEE Main Roll No. as per JEE-Main admit card etc. and create your passwords/ credentials for further log in.**
5. All important Instructions for Applying Online for Degree Courses and their Categories should be read carefully by the candidate. In case your entered details are wrong, software will not allow you to submit. You may contact to HSTES for its rectification, if any.

6. After sign up for registration/counseling, you will required to fill the registration page of 07 steps for registering yourself with following fields:
- (i) Gender
 - (ii) Eligible for Haryana domicile, if yes, fill you Parivar Pehchan Patra (PPP ID) Number Mandatorily
 - (iii) Category
 - (iv) Sub Category
 - (v) Physically handicapped
 - (vi) Educational qualification
 - (vii) % age marks in aggregate of all
 - (viii) % age marks in aggregate of physics, chemistry and math (in case of B.E./B.Tech.)
 - (ix) Name of School/College from where eligible educational qualification attained
 - (x) Type of School /College
 - (xi) Location of School /College
 - (xii) Parental Annual Income (Exact income from all sources) as verified from PPP ID
 - (xiii) Contact Address
 - (xiv) City/Town
 - (xv) Home District
 - (xvi) Pin Code
 - (xvii) Telephone number
 - (xviii) Mobile number
 - (xix) Email address etc.
 - (xx) Aadhaar Number (Enrolment number in case Aadhaar is not available)
 - (xxi) Bank Name
 - (xxii) Bank Account Number
 - (xxiii) IFSC Code of Bank Account.
 - (xxiv) Bank Account linked with Aadhaar or Not
 - (xxv) Passport Number
 - (xxvi) Driving License Number
 - (xxvii) Parivar Pahchan Patra Number

7. Please check all the details once again, before the submission.
8. After this, candidate will be redirected to “Registration Confirmation” page where all entered registration details are displayed for confirmation once again. If you found any detail incorrect, that can be corrected by using the option “edit registration details” otherwise “**Click here to continue**”, if all the registration details shown are correct.
9. Once you proceeded from the above step, **your registration details can't be changed or edited**, so click on “**Registration Confirmation**” page when all your particulars are correct. In exceptional case, you may have to visit/contact HSTES only.
10. If any of the details are incorrect, please check the details once again. For any correction/ verification, you may contact HSTES on toll free number **18001373735**.
11. PPP ID shall remain mandatory for Haryana students for taking admissions in B.E/ B.Tech & B.Arch. Courses. Also, the caste/reservation/financial benefits given to the candidate shall be on the basis of verified caste/income fetched through PPP. Any unverified data of PPP of the candidate shall lead to his candidature considered in general category only. All the candidates seeking admission are advised to get their PPP ID get verified. Refer to website <https://meraparivar.haryana.gov.in>.
12. The candidate shall upload his/her following certificates/ documents to participate in Centralized Online counseling on website <https://techadmissionshry.gov.in>, as per key dates :
 - I. **Rest of Haryana Category (RoHC):** Candidates are required to produce any of the following for the consideration in Resident of other than Haryana State Category (RoHC), if the candidate does not have their PPP ID :
 - a. Other State “Domicile Certificate” issued by Competent Authority of other State.
 - b. 10+2 or Latest Qualification Proof from State Other than Haryana.
 - c. Affidavit from the parents working as Govt. Employee in State other than the Haryana State.
 - II. **Haryana Residence Certificate** (In case candidate has not passed qualifying exam from the School situated in Haryana).:
 - a. The candidates having verified PPP ID No. are resident of Haryana.

Note:- Candidates, who has passed his/her qualifying examination from a Board/ Recognized School situated in the State of Haryana will be deemed to be Haryana resident and will not be required to submit certificates of Bonafide residents of Haryana. **However, Haryana Candidates should fill their Parivar Pehchan Patra Number (PPP ID) Number mandatorily. Therefore, all the candidates claiming Haryana Reservation & seeking admission are advised to get prepare & verified their PPP ID. Refer to website <https://meraparivar.haryana.gov.in>.**

- b. Certificate from the Employer in the case of Employee of Govt. of Haryana, members of All India Services born on Haryana Cadre, Employees of Statutory Bodies/ Corporations as per **Annexure-II**, if applicable.

III. Reserve Category Certificate:-

- a. Scheduled Caste (SC) Certificate, Deprived Schedule Caste (SCD) certificate, Backward Class Certificate (BCA or BCB), if applicable and creamy layer / annual parental income certificate as per No. 491-SW (1)-2021 dated 17 November, 2021 and should be matched / verified from their PPP ID.
- b. Certificate in respect of Divyang (PH) Candidates as per as per the PPP ID of the candidate.
- c. Certificate required to be furnished by the Children & Grand – children of Freedom Fighters as per **Annexure-IV**, if applicable.
- d. Certificate from wards of Deceased/ Disabled/ Discharged Military/ Para Military Personnel/ Ex-Servicemen or Ex-Personnel of Para-Military Forces **Annexure-V**.
- e. Certificate from wards of ex-employee of Indian Defense Services/ Para Military
- f. Forces-**Annexure-VI**.

III. Annual Parental Income, in case of TFW, BCA and BCB Categories as per the PPP ID of the candidate

IV. Income and asset certificate in case of EWS category as per Annexure-XI.

- V. Relevant Kashmiri Migrants (KM) certificate in the support of their claim from the competent authority or Relief Commissioner.

VI. Relevant certificate of HGST (Haryana Govt School Topper) as per Annexure-X.

13. **After** log in/sign in on www.techadmissionshry.gov.in , the candidate will move to fill his/ her eligible choices displayed on the screen.
14. **Candidates should strictly keep records of this password for their own use only and not to disclose this to others. In the event of sharing of password, candidate will be solely responsible for the change of registration details, choice etc.** In the event of losing or forgetting of password, the same can be retrieved by the candidate on replying the queries by the system on the counseling website.
15. Candidate can also see his eligible choices and can take the print out of his/her eligible Choices. Number of seats available in an institution will be displayed as per the eligibility/category. The non-availability of a seat in an institute for which a candidate is not eligible will not be displayed to him / her.
16. Candidate will fill his /her choices by clicking on Fill/Modify choice and fill his/her Choices priority wise by clicking on add choice button (+) in left frame. Candidate should save the filled choices also.
17. **To increase the probability of getting a seat, candidates are advised to fill maximum eligible choices.**
18. After filling the choices, Candidate will lock his/her choices. Locking choices means Candidates finally filled his /her choice.
19. Candidate can unlock his/her choices and can edit, sort his/her choices in specified time period which is available on key date's link (choice locking starts, choice locking ends) on the website. Candidate should lock his/her filled choice for seat allotment result.
20. In case candidate make changes in his/ her registration details, he/ she has to fill the choices again as previous choices will be deleted automatically by the system as soon as any changes is made in registration details.
21. After this, Candidate has to wait for result of desired course as per **key dates**.

22. Seat Allotment Result publishing date is available on Key date's section on the website.
23. After the declaration of result, candidate will log in to the counseling website <https://techadmissionshry.gov.in> by entering his/her Roll No. & Password and click on Provisional Seat Allotment result. If candidate has been allotted a seat then a page showing provisional seat allotment letter appears which shows Institute name, branch allotted to a candidate, Allotment Status and reporting duration.
24. Candidate should download Provisional Seat Allotment letter, and should physically report to allotted institute between specified reporting dates for taking admission.
25. **Candidates who are willing to take admission in the allotted institution should report physically in the allotted institute and deposit the semester fee (as mentioned in Appendix-F) at the time of reporting (as mentioned in key dates), to take admission in the allotted institute. However, the confirmation of Provisional Admission will be done after verification of uploaded documents by the allotted institute.**
26. After that the candidate will obtain the computer generated "Provisional Admission Slip" from institute and in this way candidate can reserve a seat or confirm the seat.
27. **For up gradation of the allotted seat, a candidate should participate in subsequent counseling.**
28. **For that the candidate will login on website <https://techadmissionshry.gov.in> and click on the undertaking that "I understand and accept that, by participating in this counseling, my earlier admission/allotment, if any, will be cancelled automatically, in case I get new allotment of seat by participating in next counseling".**
29. Candidate has to check the undertaking and click on Accept Participation and Proceed to participate in further counseling. **Candidate is advised to ONLY opt for the choice(s) which is/are better than the seat reserved in previous counseling.** Thus

candidates are advised to fill the choices in order of priority only to upgrade. The candidates who wish to retain the reported seat are advised not to opt for subsequent counseling. However, if a candidate participates in the 2nd Counseling and after filling the choices he/she feels that he/she should not have opted for 2nd counseling then at this stage he/she should delete all the choices filled by him/her to retain the seat reported through 1st counseling.

30. If candidate wants to change his/her registration details in B.E./B.Tech. Course, then candidate has to approach HSTES for modification in his/her registration details along with relevant certificates (except the details fetched and verified from PPP ID). By changing registration details, candidate filled up choices, if any, would be deleted and eligible choices of candidate may be affected.

31. For all subsequent counseling's, step 11 to 28 will repeat.

Things to Remember

- For withdrawal of fee, the candidate should submit a request in the institution concerned well before cut-off date of admissions/ or as per key dates. After withdrawal, the seat shall be cancelled and shall be allotted to next eligible candidate in queue.
- In case a candidate gets a new seat in subsequent counseling, the earlier allotment/admission, if any, stand cancelled automatically.
- In case a candidate upgrades to a new discipline in the same institution, he/she should report again in the allotted institution and deposit one semester fees again in new allotted institute. The Candidate will make a request to the previous allotted institute for refund of the semester fee deposited by him/her at the earliest through e-mail under intimation to HSTES before the last date of refund of Fee.
- If a candidate upgrades to a new institute in subsequent online counseling, then candidate need to deposit online semester fees again for the new allotted seat, although candidate will confirm his/her acceptance of seat at the newly allotted institute. If not accepted then both the seats stand cancelled. In case of cancellation of online provisional admission, candidate should submit fee withdrawal request to the HSTES.

- The candidates who did not get seat in previous counseling or who are not satisfied with the allotted seat may try in subsequent counseling for getting a seat or upgradation as per the case respectively.
- Once the seat is allotted in subsequent counseling, the previous allotted seat will automatically be cancelled.
- After allotment of seat in subsequent counseling, the candidate must report at the allotted institute and in case of non-reporting by the candidate, the allotted seat will also be cancelled automatically **(previously allotted seat got cancelled due to new allotment of seat in subsequent counseling and newly allotted seat got canceled due to non-reporting)** and that seat will be automatically offered to the candidates in the next subsequent counseling. **Previously allotted seat will not be given to candidate by any means after allotment of seat in the subsequent counseling even if it remains vacant.**

7.2 COUNSELING FOR KASHMIRI MIGRANTS (KM)/HARYANA GOVT. SCHOOL TOPPERS (HGST)/ TUITION FEE WAIVER (TFW)/ECONOMICALLY WEAKER SECTION (EWS) including HARIHAR SEATS FOR B.E. /B. TECH. COURSE SHALL BE DONE ONLINE.

- Kashmiri Migrants, Haryana Govt. School Toppers, Economically Weaker Section, Tuition fee waiver scheme candidate shall opt his/her category clearly during the online registration on <https://techadmissionshry.gov.in>. and upload the desired documents as per the procedure mentioned at **Chapter-3**.
- Kashmiri Migrants candidates will be required to have the original certificate of Migration duly signed by the competent authority or Relief commissioner.
- **The candidate applying for Tuition Fee waiver Scheme should have Annual income of Parents / Guardians should be less than Rs.8.00 lakh from all sources and verified from his/her PPP ID.** Counseling for Tuition Fee Waiver Scheme seats shall be done online for all institutions approved by the AICTE.
- **The candidate applying for Economically Weaker Section (EWS) will produce EWS Income and Asset Certificate issued by the competent authority.**
- The candidate belongs to HARIHAR Category will produce the HARIHAR Certificate duly issued by the District Level Committee. The candidate of HARIHAR Category will be considered under Open /EWS Category seats in Govt. institutions.
- In case of Haryana Government School Topper (HGST) of B. Tech. Course, the candidates will produce a certificate, as per **Annexure-X**, in the support of their claim from the Principal/Headmaster of the Govt. School of which the candidate is topper clearly stating the strength of class etc. They should also show the original mark-sheet

along with them during time of reporting at the time of admission in the Institute.

- Candidates applying for *TFW* are required to opt the TFW Category while filling the Online Application form on the website <https://techadmissionshry.gov.in> (in case of B. Tech) on the basis of Roll No. of JEE Main 2024.

Note: Candidates may refer leading news-papers for advertisement or website www.hstes.org.in and <https://techadmissionshry.gov.in> (in case of any change in Key Dates for KM, TFW, EWS & HGST). KM, TFW & HGST categories are not available for B.Arch. course.

7.3 COUNSELING PROCEDURE FOR ADMISSION TO B.ARCH. COURSE:

1. The admission seeker for B.Arch. Course need to register online at <https://techadmissionshry.gov.in> and shall upload his/her Score card of valid NATA -2024/ any other aptitude test recognized by the COA (PDF of Max 100 KB Size) and detailed marks certificate of Qualifying exam (PDF of Max 100 KB Size) on online application form on website <https://techadmissionshry.gov.in>.
2. The Candidate will get the Unique Roll no. during registration on <https://techadmissionshry.gov.in>. At the time of counseling, the candidates are required to sign up by using their credentials generated during registration / filling online application form at <https://techadmissionshry.gov.in> and fill their order of choices for participating in Online counseling as per key dates.
3. However, the relevant documents/credentials as mentioned in Chapter-8 shall also be required at the time of physically reporting in the Institute; otherwise allotted seat will be cancelled by the reporting institute
4. The Merit list (B. Arch) shall be displayed on the website www.hstes.org.in as per “Key Dates”.
5. EWS Candidate will apply on <https://techadmissionshry.gov.in> and upload the Income and Asset Certificate for EWS issued by the competent authority alongwith other requisites documents during registration on www.techadmissions.hry.gov.in separately.
Note: The candidates are required to participate in online counseling through <https://techadmissionshry.gov.in>. after display of merit list for the eligible candidates as per key dates.

7.4 COUNSELING PROCEDURE FOR 25% SEATS IN CASE OF B.E./B. TECH & B. ARCH COURSE TO BE FILLED BY THE PRIVATE INSTITUTIONS INCLUDING LEFT OVER/ UNFILLED SEATS OF ONLINE COUNSELING TO BE FILLED BY ALL CONCERNED INSTITUTES AT THEIR OWN LEVEL.

1. Private institutions shall fill 25% seats (including 15% seats for children/ wards of NRIs) in B. Tech. and B. Arch. courses at their own level in a just and transparent manner for which they shall invite the applications, prepare and display the merit list. The procedure shall be displayed by the Institute concerned on its website.
 2. All institutions shall fill left over/ unfilled seats of online counseling at their own level in a just and transparent manner as per the judgment of Hon'ble Supreme Court in Civil Appeal no. 9048 of 2012 titled as Parshavnath Charitable & Ors Vs. AICTE & Ors. For this the institute shall dully advertise and notify the leftover/vacant seats and shall invite the applications, prepare and display the merit list. The procedure shall be displayed by the Institute concerned on its website and in newspapers.
 3. All the institutions shall make these admissions before final cutoff date of admissions and no institute shall be allowed to make admission after Last cut off date i.e. the last date fixed by Hon'ble Supreme Court or AICTE.
 3. The minimum eligibility condition for these seats shall remain the same as that for 75% seats to be filled by the Haryana State Technical Education Society.
 5. In the event of seats remaining vacant in B.E./ B. Tech course, if any, the vacant seats may be filled up before final cut of date admissions firstly on the basis of JEE- MAIN 2024 merit and only thereafter on the basis of marks of qualifying examination.
 6. In case of B. Arch, seats remaining vacant, if any, the vacant seats may be filled up before final cutoff date of admissions on the basis of NATA-2024 merit only i.e. valid NATA-2024 score (percentile) or any other aptitude test recognized by the COA and marks secured in the qualifying examination in the ratio of 50:50.
 5. In any case all kind of admissions shall be done before the final cut-off date admissions (as mentioned in key dates) and the fee fixed by the Admission and Fee Regulatory Committee (A&FRC) shall be charged as per the laid down procedure. In any case higher fee shall not be charged.
 6. The final list of admitted candidates (including the institute level admission) should be uploaded online on www.intrahstes.gov.in by the institutes by the last cut of date of admissions, positively, so that the same may be forwarded online to the concerned Universities. The wrong admissions, whatsoever, shall not be permitted.
- **Admission Data Management Fee (Rs.200/- per admission) shall be charged one time by HSTES in respect of all admissions (Centralized Admissions and Institute Level admissions) in Self Financing Institutions including un-aided branches of Aided Institutions from the academic session 2016-17 onwards. The said Fee be charged from the admitted students by the concerned institute and be credited/ deposited in HSTES account.**

CHAPTER-8
PHYSICAL REPORTING OF THE CANDIDATE

8.1 PHYSICAL REPORTING OF THE SELECTED CANDIDATE TO THE ALLOTTED INSTITUTE:

1. The candidate shall download the **Provisional Allotment Letter** from website <https://techadmissionshry.gov.in> and if the candidate is satisfied with the allotted seat then he/she shall report Physically to the allotted institute as per the key dates and deposit semester fees.
2. Selected candidates may go physically in the allotted institute for reporting by following COVID protocols (SOPs) as per Govt. orders at that time in this regard. They are required to report physically during reporting period for that particular counseling to the allotted institute for which they have been selected.
3. The candidate, who has been allotted a seat in any institute during a particular counseling, has to report physically for that seat during reporting period for that particular counseling to the allotted institute otherwise that seat will be cancelled automatically. Such type of candidates can go for subsequent counseling by selecting again the choices priority wise & after the result of subsequent counseling he/ she may deposit semester fee and report physically to the allotted institute during the reporting period as per Key Dates.
4. Institute will first check candidate's provisional seat allotment letter online and verify all documents of the candidate as uploaded by him/her during online centralized counseling and proof of deposition of admission/tuition/semester fee. If all the documents uploaded by the candidates are found correct, the system will generate Provisional Admission Slip. If some of the documents of candidate are not available/incorrect, then institute will issue system generated deficiency message or contact to the candidate through E- mail/SMS or telephonically.
5. On obtaining the deficiency message, candidate will again submit the corrected document physically to the reporting institute between reporting dates as per key dates and institute will again check candidate's document and if institute found the documents correct then Provisional admission slip shall be issued to the candidate.

6. If in case, there is minor discrepancy (like scanned of documents are not clear or uploaded category certificates in place of income certificate and vice versa) then institute may upload the correct document after seeking it online from the candidate.
7. The Director-Principal/ Registrar of the concerned Institute/ University Department shall satisfy himself / herself regarding the authenticity of all certificates uploaded online by the candidates for the purpose of their admission in B. Tech. and B. Arch. course and shall be verified online by the institution from the issuing authority of the certificates. The Director-Principal/ Registrar should also ascertain the identity of the candidate by verifying his photo from photo available at <https://techadmissionshry.gov.in>. The Director-Principal/ Registrar of the concerned Institute shall be held responsible for any ineligible admission made in their institute. Anyhow, if the affiliating University, so desires, the original certificates from the candidate can be demanded through the institute of his admission for any purpose whatsoever these may be.
8. Institutes would REPORT ONLINE on www.intrahstes.gov.in for each selected candidate who reported to the institute and a "Provisional Admission Slip" from institute to be issued to the candidate after confirmation of reporting by the candidate.
9. If a candidate upgrades to a new institute in subsequent online counseling, then candidate will again deposit the admission/tuition fees again for the new allotted seat, although candidate will confirm his/ her acceptance of seat at the newly allotted institute. If not accepted then both the seats stand cancelled. In case of cancellation of online provisional admission, candidate should submit fee withdrawal request to the HSTES. After Successful reporting in new allotted institute the candidate will submit the fee refund application to the previously allotted institute immediately through e-mail/physically and retain the receipt of the same.
10. After allotment of seat in subsequent counseling, the candidate must report physically to the allotted institute and in case of non-reporting by the candidate, the allotted seat will also be cancelled automatically. (Previously allotted seat got cancelled due to new allotment of seat in subsequent counseling and newly allotted seat got cancelled due to non-reporting) and that seat will be automatically offered to candidates in the subsequent counseling. Previously allotted seat will not be given to candidate by any means after allotment of seat in the subsequent counseling even if it remains vacant.

11. Selected candidates are required to report during reporting period for that particular counseling at the allotted institutes for which they have been selected, with the allotment letter generated from the website along with all requisite documents/ certificates/ testimonials/ Annual Parental income Certificate from all sources (in case TFW quota candidates/ BC candidates)/ EWS income and asset certificate.
12. The candidate, who has been allotted a seat in any institute during a particular counseling, has to report for that seat during reporting period for that particular counseling at the allotted institute otherwise that seat will be cancelled automatically. Such type of candidates can go for subsequent counseling by selecting again the choices priority wise & after the result of subsequent counseling he/ she may report in allotted institute during the reporting period as per Key Dates.
13. Institutes must update / report ONLINE on www.intrahstes.gov.in for each candidate whether he/she reported to the institute through online/offline mode.

8.2 LIST OF DOCUMENTS TO BE VERIFIED BY THE ALLOTTED INSTITUTE:

8.4 POST COUNSELING INSTRUCTIONS FOR THE INSTITUTES:

- **Institutes are required to update the admissions online on www.intrahstes.gov.in strictly as per Key Dates so that the subsequent counseling may be conducted as per schedule, failing which they will be fined heavily.**
- All admissions by the institutes including institute level admissions are to be updated/ reported online, as and when they report/ admit the candidates. No permissions of any kind would be provided for admitting students, if not reported online as per Key Dates/ Schedule. The reported candidates for centralized as well as institute level admissions would only be forwarded online to the respective universities.
- While updating institute level admissions online, entry shall be made with JEE (Main)/ NATA Roll No. for the candidates who have taken JEE (Main), NATA test.
- No excuse from institutes regarding non-updation of admissions because of internet not working, etc. would be entertained in any case. If institutes internet facility does not work, they should use the facility of nearby institutes or other internet points or cyber café for Reporting. The counseling would not be delayed because of them and no seats of institute would be filled after that.
- No excess admissions shall be made by any institute.

- The institute shall submit one set of documents self-attested by the admitted candidates (whose details uploaded on HSTES portal upto Last Cut-off date of Admissions) and duly authenticated by Institute to the concerned affiliating University for authentication and registration purpose. **The concerned affiliating University will further authenticate the documents of the admitted students submitted by the institute after one month of last cut off date of admissions for registration of the students.**
- Any admission made after the last cutoff date of admission shall be treated as wrong and illegal and will not be permitted/ updated at www.intrahstes.gov.in

NOTE: Respective institute shall check the admission status of all the candidates admitted at the institute in subsequent counseling and make the candidates aware through notification on first day of physical reporting itself whose admissions have been cancelled due to up-gradation, so that he/ she may check his/ her allotment status online on website and report physically at newly allotted institute/ seat within reporting period of subsequent counseling.

CHAPTER-9

REFUND OF FEE

1. **The Registration Fee of Rs.1000/- for General Category and Rs.700/- for all reserved category in B.E./ B. Tech & B.Arch. course 2024 deposited in HSTES account are non-refundable.**
2. **Regarding refund of fee:** As per AICTE Approval Hand Book 2024-25, the following policy of Refund of fee will be applicable for all institutions:-
 - In the event of a student withdrawing before the start of the Course, the entire Fee collected from the student, after a deduction of the processing Fee of not more than Rs. 1000/- (Rupees One Thousand only) shall be refunded by the Institution. It would not be permissible for Institutions to retain the School/ Institution Leaving Certificates in original.
 - In case, if a student leaves after joining the Course and if the vacated seat is consequently filled by another student by the last date of admission, the Institution must refund the Fee collected after a deduction of the processing Fee of not more than Rs. 1000/- (Rupees One Thousand only) and proportionate deductions of monthly Fee and hostel rent, where applicable.
 - The last date for withdrawal of admissions for the purpose of refund of Fee is **as per the AICTE Academic Calendar.**
 - In case the vacated seat is not filled, the Institution should refund the Security Deposit and return the original documents.
 - The Institution should not demand Fee for the subsequent years from the students cancelling their admission at any point of time. Fee refund along with the return of Certificates should be completed within 7 days.
 - Institutions not following guidelines issued by the AICTE regarding refund of Fee for cancellation of admission or delaying refunds shall be liable to punitive action as stipulated in the AICTE regulations/APH 2024-25.
 - **NOTE: Any changes in the Schedule for any of the academic related activities as notified by the AICTE from time to time are binding on all the AICTE Approved Universities/Institutions.**

CHAPTER-11

RAGGING

1. Ragging in educational institutions is banned and any one indulging in ragging is likely to be punished appropriately, which may include expulsion from the institution, suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take the shape of (i) withholding scholarships or other benefits, (ii) debarring from representation in events, (iii) withholding results, (iv) suspension or expulsion from hostel or mess, and the like. If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded to act as a deterrent.
2. The following will be termed as the act of ragging of ragging vide UGC regulations 29.06.2016 and AICTE approval process handbook 2024-25:

“(j) any act of physical or mental abuse (including bullying and exclusion) targeted at another students (fresher or otherwise) on the ground of colour, race, religion, caste ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic, identity, place of birth, place of residence or economic background.”

CHAPTER-12

Instruction to curb the events of Eve-Teasing

In compliance of directions of Hon'ble Supreme Court of India in case civil Appeal no. 8513 of 2012 titled the Deputy Inspector General of Police and Anr. Vs S.S. Samuthiram, the State Government that issued the following instructions for strict compliance by all the Technical Education institutions of the State to curb the events of Eve-Teasing in/ around their campuses and emphasis should be given to curb the same from the Society at large.

1. Head of the Institutions of all Technical Education Institutions shall make arrangements to depute staff to be present at the main gates during opening and closing of institution hours.
2. A women grievance cell be constituted with senior women faculty as members. A suggestion/ compliant box should be in place at the convenient place, so that the students may submit their grievance/ complaints.
3. Information regarding awareness for protection of women against Eve-Teasing and any other form of sexual harassment should be displayed on the notice boards of the Institution and hostels. Helpline numbers also be displayed on the hoardings for informing any incident of eve-teasing.
4. Deputy Commissioners, Supdt. Of Police and SHO of the area may be requested to make arrangements for PCR vehicles to be stationed near education institutions during opening and closing hours and police patrolling must be intensified near the educational institutions/ campus to ensure that students are not harassed by eve-teasers.
5. Responsibility of the Heads of the Institutions and Management will be fixed for failure to curb the incidents of eve-teasing in and around their respective institutions.
6. Faculty should be deputed to classrooms during free periods to ensure that no girl shall be allowed to sit alone in classrooms during free period and a separate girls common room should be made functional in the institution.
7. CCTV Cameras be installed at gate of education institutions and in the campus and classrooms.
8. One male or female official duly armed with walky-talky set/ mobile phone be deputed in Vehicles carrying working women or girl students.
9. It should be ensured that liquor shops are placed at maximum distance from the educational institutions/ campus.
10. Effective steps to stop eve-teasing by creating awareness through awareness programs, seminars and discussion be taken up at the institution level and also other steps or measure be used to curb the evil of eve-teasing with the help of Women Organizations and Women Commissions of the State involving them in awareness programs.
11. The Head of the Institution and Management is hereby directed to take care of girls students and female faculty for the incidence of eve-teasing reported by them even outside the campus.

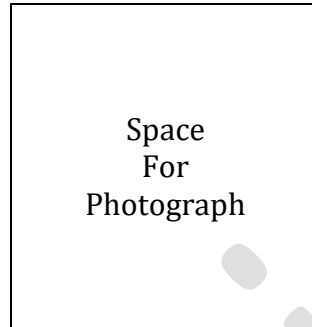

Subject: "Bonafide residents of Haryana- Guidelines regarding".

1. I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subject noted above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institution (including technical/ medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and others reported as AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate:-
 - i) Candidates, who have passed the examination qualifying them for selection in an institution from a school/ college in Haryana.
 - ii) Children/ Wards (if parents are not living)/ Dependents :-
 - a) Of the employees of Haryana State posted in or outside Haryana State or working on deputation;
 - b) Of the employees of the statutory bodies/ corporations established by or under an Act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana;
 - c) Of the employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government.
 - iii) Children/ Wards (if parents not living)/ dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.
 - iv) Children/ Wards (if parents are not living)/ dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a State other than Haryana or he has settled after retirement in or outside Haryana.
 - v) Children/ Wards (if parents are not living)/ dependents or persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana.
 - vi) The wives of such persons who are bonafide residents of Haryana irrespective of the fact that they had belonged to any other State before marriage.
 - vii) Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/ guardians (if parents are not living) of persons belonging to any one of the above mentioned categories are:

- a) Citizens of India;
 - b) Produce an affidavit to the effect that they or their children/ wards (if parents are not living)/ dependents have not obtained the benefit of Resident in any other State.
2. All candidates claiming to be bonafide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/ General Assistant to Deputy Commissioner or Sub-Divisional Officer (Civil) of the District/ Sub-Divisions to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/ Wards/ Dependents of Haryana Govt. employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children/ Wards/ Dependents of pensioners of Haryana Govt. or in respect of the Children/ Wards/ Dependents of the employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/ Wards/ Dependents of the employees and retirees of the Statutory Bodies/ Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana or outside Haryana, should be by their respective Heads of Departments.
 3. Candidates seeking admission in educational institutions (including medical and technical institutions) located in Haryana may not be required to produce Resident Certificate, if they have passed the examination from a school/ college situated in Haryana. For this purpose, a certificate of the Principal/ Headmaster from concerned institution where the Children/ Wards studied last should be considered sufficient. The Principal/ Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.
 4. If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim was false, the student shall be removed from the institution, all fees and other dues paid up to the date of such removal shall be confiscated. The Principal/ Headmaster may take such other action against the student and his/her parents/guardians as he may deem proper in the circumstances of any particular case.
 5. For the purpose of uniformity for issuing certificate of Residence in the case of various categories to be issued by the competent Authorities, proformas have been prescribed which are enclosed herewith.
 6. These instructions may kindly be noted carefully for compliance and the receipt of this letter may please be acknowledged.

Sir,

1. I am directed to invite your attention to Haryana Government letter Nos. 62/17/95-2GSIII, dated 03.10.1996, No. 22/51/93-3GTSIII, dated 12.08.93 and even No. dated 14.10.97 on the subject noted above wherein instructions regarding the Caste Certificates (SC/BC/OBC), and Resident Certificates have been issued.
The policy has been reviewed keeping in view the various courts judgements and the hardships caused to the individuals in obtaining above quoted certificates. Government is of the view that the procedure be institutionalized by delegating powers at proper level for ensuring speedy disposal of work without any harassment or exploitation. The present modification of the policy also aims at simplifying the procedure for obtaining certificate by an individual falling under the reserved categories.
2. The matter has been reconsidered in depth by the State Government in view of the problems being faced by the Government employees in obtaining these certificates. With a view to improve the existing system in issuing various certificates, it has been decided by the Government that henceforth Circle Revenue Officers (Tehsildars/ Naib Tehsildar-cum-Executive Magistrate) concerned will be authorized to issue Resident as well as Caste Certificate (SC/BC/OBC) after getting the verification done through the subordinate revenue staff in case of applicants residing in the rural area and through the Corporation concerned in case of applicants residing in urban areas. It has further been decided that in case of Haryana Government employees serving in the offices located at Chandigarh/ Panchkula and residing at Chandigarh/ Panchkula, the Resident Certificate and the Caste Certificates to SC/BC employees and for their children .may be issued by their respective Heads of Departments also.
3. The validity of Resident Certificate issued by the competent authority shall be as long as the holder of this certificate maintains his residential address in Haryana State.
4. SC certificate once issued be valid as long as the caste is not removed from the Schedule of the Constitution and BC certificate shall be valid for life from the date of issue of the certificate or till the applicant does not fall into creamy layer category as defined from time to time. The applicant applying for BC certificate would also submit a self declaration on simple paper that he does not fall under creamy layer category. However, if the certificate has been obtained by fraud or misrepresentation or concealment of facts or by some other means, the said certificate shall be declared as invalid/ non-est and benefit taken by the applicant will be

withdrawn and a criminal case shall be registered against the applicant misrepresenting the facts as well as against the guilty officers/ officials, if any. In addition, Social Justice & Empowerment Department, Haryana is being directed to finalize the modalities and procedure to constitute the Scrutiny Committee.

The files relating to Caste and Resident certificate shall be retained for 10 years and Register shall be retained permanently. The proformae of the application form, Register and SC/BC certificates prescribed by the Government shall be followed by all the Departments/ Institutions in letter and spirit as it has come to the notice of the Govt. that some Department/ Institutions demand such certificates in proformae which are at variance with the proformae in which these certificates are being issued by the competent authorities (Tehsildar/ Naib Tehsildar/ HODs). It is, therefore, decided that the Departments/ Institutions shall accept these certificates only in the proformae in which these are being issued by the competent authorities which have been prescribed by the Govt. itself.

5. To make institutional arrangements, it has also been decided that in future the Resident and Caste certificates will be issued to all the students studying in class 8th every year as per the time schedule given below :-

i	Filling of application form by the Parents/ students.	1 st Nov. to 10 th Nov. every year

iv	Verification & issue of certificate by CRO	Upto 31 st Jan. every Year

6. All the application forms of a particular School may be sent to the Tehsildar/ Naib Tehsildar concerned preferably at one go so that the certificates are issued and sent back to the Headmasters of Government Schools/ Private Schools for distribution to the concerned students. The Head Teacher/ Headmaster shall be responsible for getting the application forms filled and files prepared of all the students presently studying in Class-VIII to XII will be issued these certificates during the months of January, 2004 to March, 2004. The schedule will be finalized by the concerned Deputy Commissioner in this regard.
7. It has been further decided that in case of SC/BC students claiming benefit under various welfare schemes upto Class IX, the benefits will be given by the Headmaster/ Head Teacher after getting the verification done from Sarpanch/ Nambardar/ MC and a caste certificate issued by the CRO (Tehsildar/ Naib Tehsildar) may not be demanded for this purpose by the School authorities.
8. The matter regarding issue of income certificate to the students for claiming various benefits in educational institutions has been considered and it has been decided that in future the

income certificate for educational purpose will be issued by the CRO (Tehsildar/ Naib Tehsildar concerned) and income certificate for other purposes by the SDO (C) concerned taking into account income of the applicant from various sources including agriculture, trade, profession, salary etc. The verification will be got done through the subordinate revenue staff in case of applicants residing in rural areas and through the Executing Officers/ Secretary of the concerned Municipal Committee/ Municipal Corporation in case of applicants residing in urban areas.

9. It has also been brought to the notice of the Government that when posts are advertised, fairly large number of candidates applies for such posts and Haryana Public Service Commission/ Haryana Staff Selection Commission/ Department demand attested copies of Resident/ Caste certificates and other documents from the candidates. This creates not only financial problems for the unemployed youths but also increases the workload in the offices. Similar is the position in case of admission to educational/ professional Engineering institutions. To give relief to the public, it has been decided that at the time of applying for job or for admission in educational institutions including technical/ professional institutions etc. self attested photocopy of the certificate about the residence and caste status shall be sufficient and at the time of final interview/ selection, original papers, including Castes and Resident Certificate issued by the competent authorities may be obtained/ examined/ inspected by the concerned departments/ institutions and attested copies thereof be kept in record. The fact may also be cross-checked/ verified at the time of verification of the antecedents of the applicants before he/she joins the Government service. Similar practice will be followed for degrees/ mark-sheets/ other certificates of academic qualifications. Necessary action to amend/ revise the application form in this regard shall be taken by Haryana Public Service Commission/ Haryana Staff Selection Commission/ Head of the Departments/ Universities etc. at their own level under intimation to the Government.

These instructions may be brought to the knowledge of all for strict compliance.

Subject: Bonafide residents of Haryana-guidelines regarding.

Sir,

1. I am directed to invite your attention to Haryana Government circular letter No. 62/17/95-6GSI, dated 3.10.96 regarding the subject mentioned above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Bonafide residents of Haryana for the purpose of admission of educational institutions (including technical/ medical institutions).
2. Several departments have sought clarification from the State Govt. whether adhoc/ contract/ daily-waged employees are also covered under these institutions.
3. The matter has been examined by the Government. It is clarified that only regular employees of the State Govt./ Statutory bodies/ corporations and Govt. of India mentioned in the above instructions and not ad hoc/ contract/ daily-waged of these State Govt./ Statutory bodies/ corporations fall within the ambit of these instructions. Accordingly, in the sub-Clause (a), (b) and (c) of Clause (ii) in para 1 of the instructions in question, for the word "employee" the word 'regular employee' is substituted and should be read as such.

These instructions may be noted carefully for compliance.

I am directed to invite your attention to Government instructions No. 62/17/95-6GS-I, dated 03.10.1996 and No. 62/03/2021-6GS-I, dated 14.01.2021 on the subject cited above and to say that Government has decided to further revise para 1(v) of the instructions as under :

1(v) (A) For the purpose of Employment of Haryana Residents under the Haryana State Employment of Local Candidates, Act 2020 and for the purpose of Grant of Employment Generation Subsidy to industrial units under the Haryana Employment and Entrepreneurship Policy, 2020 or other sector specific industrial policies - Children/dependents/wards (if parents are not living) of persons who have permanent home in Haryana since a period not less than Five (5) years; or who have permanent home in Haryana since a period not less than Five (5) years but on account of their occupation they are living outside Haryana; or who do not have permanent residence in Haryana but have been residing in Haryana for a period not less than Five (5) years.

(B) For the purpose of admissions, scholarships, unemployment allowance and weightage under Socio-economic Criteria - Children/dependents/wards (if parents are not living) of persons who have permanent home in Haryana since a period not less than Fifteen (15) years; or who have permanent home in Haryana since a period not less than Fifteen (15) years but on account of their occupation they are living outside Haryana; or who do not have permanent residence in Haryana but have been residing in Haryana for a period not less than Fifteen (15) years.

2. These instructions will be applicable with immediate effect and may please be brought to the notice of all concerned.

	b	The scheme shall be mandatory for all Institutions approved by the Council.
	C	Requirements and Eligibility
	•	Sons/ Daughters of parents whose annual income from all sources does not exceed Rs.8.00 Lakh.
	•	The Waiver is limited to the tuition fee as approved by the State Level Fee Committee for Self Financing Institutions and by the Government for the Government/ Government aided Institutions. All other fees except tuition fee shall have to be paid by the beneficiary.
	d	Admission Procedure
	•	Under this Scheme, up to a maximum of 5% of “Approved Intake” per Course shall be available for this admission. These seats shall be supernumerary in nature. These supernumerary seats shall be available only to such Course(s) in an Institution, where a minimum of 50% of “Approved Intake” are filled up in last academic year.
	•	The Competent Authority to effect this admission is the State Government/ UT or its designated authority.
	•	In the event of non-availability of students in this category the same shall not be given to any other category of candidates.
	•	The State Admission Authority shall invite applications under this category, make a separate merit list for this category and effect admission on the basis of the merit list so generated.
	•	The Institutions shall publish in their Brochure and Web site the details of this scheme.
	•	Competent Authority for admission shall submit a separate list of the students admitted under this category to the Institution to which they are admitted for compliance.
	•	A letter in this respect shall be issued by the Competent Authority for admission to each beneficiary student admitted under this scheme and he/ she shall not be allowed to change the Institution/ Course under any circumstances.
	•	The Institutions shall also display information regarding admitted candidates in their Web site for information to the students and other stakeholders.

Kindly refer to the subject cited above.

In this connection, it is intimated that Women & Child Development Department Haryana has notified “HARIHAR” (Homeless Abandoned and Surrendered Children Rehabilitation Initiative Haryana) Policy vide notification no. 111 SW (3) dated 20.07.2021 with the aim to provide Education, Financial and Employment benefits to the Abandoned and Surrendered Children who have completed the age of 18 years from the Child Care Institutions of the State and were abandoned before the age of 5 years or surrendered before the age of 1 year.

For proper implementation of “HARIHAR” policy in all Government/ Society mode and Government-Aided Institutions (Polytechnics/SIETs/State Technical Universities) under the ambit of Technical Education Department, following guidelines are issued for providing free education to such candidates:

1. Children seeking the benefit of admission under HARIHAR policy shall be Abandoned and Surrendered Children who have completed the age of 18 years from the Child Care Institutions of the State and were abandoned before the age of 05 years or surrendered before the age of 1 year.
2. All Government/ Society mode and Government-Aided Institutions (Polytechnics/ State Institutions of Engineering & Technology/ State Technical Universities) under

the ambit of Technical Education Department shall provide free education to such candidates.

3. Such candidates having Economically Weaker Section (EWS) status shall also be considered under EWS category for admission to above mentioned Technical Institutions.
4. Only such cases shall be considered for admissions which are approved by the concerned District Approval Committee headed by District Commissioner as defined vide "HARIHAR" policy dated 20.07.2021.
5. Institutions shall verify the relevant documents of the candidate from the concerned District Commissioner Office at the time of admission.
6. HSTES working under the aegis of Technical Education Department and looking after the admissions in Technical Institutes in the State will make the provision for admission of such candidates.
7. Institutions having hostel facilities must ensure free boarding/lodging facility to such students in consultation with Deputy Commissioner of the Concerned District, who will be the patron for that child and responsible for ensuring candidate's aftercare and rehabilitation upto the age of 25 years.
8. Only those facilities shall be provided at hostel and for education, for which expenses are borne by the State Govt.

Above Guidelines pertaining to "HARIHAR" policy notified by Women & Child Development Department Haryana vide notification dated 20.07.2021 shall be duly implemented in letter and spirit by all the technical institutions.
